Dear Chief Justice George and Associate Justices of the Court:

We are writing to the Court today as amicus curiae to respectfully request that the Court grant a rehearing on its own motion in this case. We only became aware of the Court's opinion in this case this week. We are deeply concerned that this Court's opinion in this case will create many unintended consequences and undermine settled insurance law.

United Policyholders was founded in 1991 as a non-profit corporation dedicated to educating the public on insurance issues and consumer rights. The organization is tax-exempt under Internal Revenue Code §501(c)(3). UP is funded by donations and grants from individuals, businesses, and foundations.

A diverse range of residential and commercial policyholders throughout the United States communicate on a regular basis with UP regarding insurance-related concerns. UP advances policyholders' interests in courts throughout the country by filing *amicus curiae* briefs in cases involving important insurance principles.

UP's growing reputation as a source of useful information for appellate courts was confirmed when our *amicus* brief was cited in the U.S. Supreme Court's opinion in <u>Humana Inc. et al v. Mary Forsyth</u> 525 U.S. 299 (1999) We have been invited by several divisions of the California Court of Appeal, to participate in oral argument as *amicus curiae*. Arguments from our *amicus curaie* brief were cited with approval by the California Supreme Court in <u>Vandenburg v. Superior Court</u>, 21 Cal.4th 815 (1999). UP has filed *amicus* briefs on behalf of policyholders in over ninety cases around the United States in the past five years.

At a minimum, we ask the Court to modify its opinion in order to address the concerns touched upon in Ms. Bader's letter.
