by and through undersigned counsel, and for its Complaint for Damages against Defendant CERTAIN UNDERWRITERS AT LLOYD'S, LONDON; Defendant SPECIALTY PROGRAM GROUP, LLC; Defendant JOHN MULLEN & CO., INC., and the DOE DEFENDANTS, alleges and avers as follows:

#### I. JURISDICTION AND VENUE

- 1. As the contract of insurance at issue herein was purchased by Plaintiffs in State of Hawai'i to insure real property and personal property located in the State of Hawai'i, and because the amount in controversy exceeds the sum of \$40,000 dollars exclusive of costs and attorney fees, this Court maintains jurisdiction over the parties and the subject matter of this Complaint. Additionally, this Court maintains jurisdiction based on the fact that one or more Defendant(s) is a Hawai'i (domestic) entity registered with the Department of Commerce and Consumer affairs with business operations and offices located in the State of Hawai'i.
- Venue is proper in this Court pursuant to HI Rev Stat Sec. 431:10-241
   (2017) inasmuch as Plaintiffs PHILIP J. HAYSMER and LANELL D. HAYSMER reside in Pahoa, Puna District, Hawai'i Island.

#### II. THE PARTIES

3. Plaintiffs PHILIP J. HAYSMER and LANELL D. HAYSMER (hereinafter referred to as the "HAYSMERS"), are both *sui juris*, and both resided together as husband and wife in their dream home formerly located at 13-3543 Luana Street, Pahoa, District of Puna, Hawai'i County (hereinafter referred to as "PROPERTY"), until being displaced by a mandatory evacuation order on May 2, 2018.

- 4. Upon information and belief, Defendant CERTAIN UNDERWRITERS AT LLOYD'S, LONDON (hereinafter referred to as "LLOYDS"), is an Alien Insurer transacting insurance business within the State of Hawai'i. LLOYDS is a multi-national insurance conglomerate that, according to its 2017 annual report to shareholders, collected over \$40 Billion Dollars in insurance policy premiums in 2017 alone. Fifty percent of those premium payments came from policyholders in the United States and Canada.
- 5. LLOYDS is the insurer identified on a certain policy of homeowner's insurance sold to the HAYSMERS. LLOYDS is neither licensed as a legal entity in the State of Hawai'i, nor is it registered with the State of Hawai'i Department of Commerce and Consumer Affairs (hereinafter referred to as "DCCA"). Upon information and belief, LLOYDS has no offices and employs no claims adjusters in the State of Hawai'i.
- 6. The State of Hawai'i Insurance Commissioner and the DCCA Insurance Division, mandate that no person shall act as an insurer and no insurer shall transact insurance business in the State other than as authorized by a certificate of authority granted to it by the Commissioner.
- 7. Upon information and belief, LLOYDS did not possess a certificate of authority to transact insurance business in the state of Hawai'i at any time period relevant to this case.
- 8. On or about November 7, 2017, LLOYDS issued a Certificate to the HAYSMERS insuring the PROPERTY for the effective policy period of October 9, 2017 to October 9, 2018 (hereinafter referred to as the "INSURANCE POLICY"). The Certificate identifies the policy number as: HGMH17710. A complete copy of the

INSURANCE POLICY consisting of 51 pages, is attached, and incorporated by reference, to this Complaint for Damages as "Exhibit A."

- Upon information and belief, LLOYDS had issued a previous Certificate insuring the PROPERTY, identified as HGMH16174, to the HAYSMERS.
- 10. The INSURANCE POLICY identifies "Monarch E & S Insurance Services, Division of SPG Insurance Solutions" (hereinafter referred to as: "MONARCH") as LLOYDS correspondent, agent, and the entity required to receive notification of a claim under the policy.
- 11. Upon information and belief, MONARCH endorsed the INSURANCE POLICY on behalf of LLOYDS.
- 12. The State of Hawai'i identifies "Monarch E & S Insurance Services" as a Trade Name registered on or about August 18, 2009 by an entity named "Borisoff Insurance Services, Inc.," a California Corporation registered in the State of Hawai'i as a "Non-Resident Insurance Producer." The Trade Name "Monarch E & S Insurance Services" expired on August 17, 2014.
- 13. The State of Hawai'i recognizes "Borisoff Insurance Services, Inc.," as a "Non-Resident Insurance Producer," that registered with the Insurance Commissioner on or about April 11, 2008 and whose license is set to expire on or about April 16, 2020.
- 14. Defendant SPECIALTY PROGRAM GROUP, LLC (hereinafter referred to as "SPG") is a Delaware Limited Liability Company registered in the State of Hawai'i as a Foreign Limited Liability Company.

- 15. The State of Hawai'i recognizes SPG as a "Non-Resident Insurance Producer" that registered with the Insurance Commissioner on or about January 18, 2017, and whose license is set to expire on or about April 16, 2020.
- 16. Upon information and belief, SPG acquired all the assets of "Borisoff Insurance Services, Inc." in 2017.
- 17. Defendant JOHN MULLEN & CO., INC. (hereinafter referred to as "MULLEN") is a Hawai'i For-Profit Corporation. MULLEN'S corporate registration filed with the State of Hawai'i identifies MULLEN'S purpose as: "Insurance Adjusting Services."
- 18. The State of Hawai'i reports that MULLEN was a "Resident Insurance Producer" until that license expired in the year 2013.
- 19. The State of Hawai'i reports that MULLEN was licensed as a "General Agent" until that license expired in 2003.
- 20. Upon information and belief, on some date in May 2018, MULLEN became an agent to LLOYDS and/or MONARCH and has been assigned to adjust, manage, and/or investigate the HAYSMERS' insurance claim, the details of which are set forth herein. Upon information and belief, MULLEN delegated its agency responsibilities to a licensed adjuster named James S. Gordon. According to the DCCA Insurance Division, Mr. Gordon became licensed as a "Resident Independent Adjuster" or about April 19, 2018.
- 21. Upon information and belief, at all times relevant to this case, James S. Gordon acted within the scope of his engagement with MULLEN.

#### III. LLOYD'S POLICY

- 22. Upon information and belief, LLOYDS is not registered with the Division of Commerce and Consumer Affairs as a legal entity. Furthermore, LLOYDS is not licensed with the Insurance Commissioner in Hawai'i.
- 23. The Declaration Page of the INSURANCE POLICY clearly states: "3. Insurance is effective with certain UNDERWRITERS AT LLOYD'S, LONDON. Percentage 100%[.]"
- 24. The INSURANCE POLICY obligated LLOYDS to "provide insurance described in the policy in return for the premium and compliance with all applicable provisions of this policy."
- 25. In reasonable reliance upon the representations made by LLOYDS and SPG, the HAYSMERS regularly paid valuable consideration in the form of a premium to bind coverage and be included as named insureds under the INSURANCE POLICY.
- 26. Upon information and belief, LLOYDS and SPG accepted premium payment(s) made by the HAYSMERS. The HAYSMERS paid all policy premium payments required of them on time and without delay.
- 27. In consideration of the policy premium payments made by the HAYSMERS, a contractual obligation was created in which LLOYDS accepted the risk to insure the HAYSMERS against direct physical loss to the HAYSMERS' dwelling, personal property, and other coverages.
- 28. The INSURANCE POLICY expressly covered losses to the HAYSMERS dwelling and personal property resulting from the occurrence of unintentional fire as a

"Peril Insured Against."

- LLOYDS and/or SPG drafted all of the terms, conditions, and exclusions contained in the INSURANCE POLICY.
- 30. The HAYSMERS did not draft any of the terms contained in the INSURANCE POLICY and did not negotiate any of the terms, conditions or exclusions drafted by LLOYDS and/or SPG, as set forth in the INSURANCE POLICY.
- 31. The HAYSMERS reasonably relied upon and depended upon the representations made by LLOYDS and/or SPG in agreeing to insure the HAYSMER'S dwelling, personal property, and other coverages.
- 32. The INSURANCE POLICY contains a term expressly consenting to the jurisdiction of a court of the HAYSMERS choosing:
- (a) "SERVICE OF SUIT (U.S.A.) It is agreed that in the event of the failure Underwriters hereon to pay any amount claimed to be due hereunder, the Underwriters hereon, at the request of the Insured (or Reinsured) will submit to the jurisdiction or a Court of competent jurisdiction within the United States District Court ...."
- 33. Relevant to the harm suffered by the HAYSMERS as a proximate cause of the respective and/or collective actions or omissions of LLOYDS, SPG, and MULLEN, set forth in further detail herein, the INSURANCE POLICY required certain duties after a loss, the terms of which are cited in pertinent part below:
- (a) "SECTION I CONDITIONS ... B. Duties After Loss[.] In case of a loss to covered property, we have no duty to provide coverage under this policy if the failure to comply with the following duties is prejudicial to us. These duties must be performed either by you, an insured seeking coverage, or a representative of either: 1. Give prompt notice to us or our agent. ... 4. Protect the property from further damage. ... 5. Cooperate with us in the investigation of a claim; ... 8. Send to us, within 60 days after our request, your signed, sworn proof of loss which sets forth, to the best of your knowledge and belief: a. The time and cause of loss; ... [a-h]."

34. To date, neither LLOYDS, SPG, nor MULLEN have sent the HAYSMERS a request for their signed sworn proof of loss as expressly required in Section I – Conditions (B) 8 of the INSURANCE POLICY. Notably, the provision requires that the proof of loss be sent "within 60 days after our request" (emphasis supplied by counsel). By not making such a request, and by delaying the payment of the claim and otherwise not properly handling this claim, Defendants have effectively frozen the HAYSMERS in their tracks, harming them in the process, and necessitating this lawsuit to remedy their losses.

## IV. THE ERUPTION OF THE KILAUEA VOLCANO

- 35. On May 2, 2018, there was a volcanic eruption at Kilauea, a shield volcano located in the Puna District on Hawai'i Island. Shortly after the eruption began, residents of areas including Leilani Estates, Nanawale Estates and Lanipuna Gardens were forced to evacuate. The HAYSMERS were one of the first residents to evacuate.
- 36. On or about May 31, 2018, a strict new mandatory evacuation order was issued by Hawai'i Island Mayor, The Honorable Harry Kim. In the Mayor's evacuation order, a 17-block swath of Leilani Estates was off limits indefinitely. Residents who remained in their homes had 24 hours to evacuate or face arrest.
- 37. The following chronology of proclamations from United States President Donald J. Trump, Hawai'i Governor David Y. Ige, and County of Hawai'i Mayor Harry Kim, cited in pertinent part, tell the grim unadorned and objective truth of the devastation suffered by Puna residents such as the HAYSMERS:
- (a) May 3, 2018: Mayor Harry Kim, County of Hawai'i, issued an Emergency Lava Proclamation, declaring, in part: "...at approximately 4:54 a.m. on May 1, 2018, United State (sic) Geological Survey (USGS) Hawai'i Volcano Observatory (HVO) issued a report that a migration of seismicity and deformation downrift (east) of Pu'u'O'o

indicates that a large area along the East Rift Zone is potentially at risk of a new outbreak, possibly in the Lower Puna area. The location of any future outbreak will determine what areas are in the path of new lava flows; ... "

- May 3, 2018: Governor David Y. Ige, Governor, State of Hawai'i, issued (b) a Proclamation, declaring, in part: "... WHEREAS, the Pu'u'O'o vent in the East Rift Zone of Kilauea volcano located in the county of Hawai'i, began erupting on January 3, 1983, and continued erupting for more than thirty-five (35) years with the majority of the lava flows advancing to the South; and WHEREAS, a lava flow has emerged in the Leilani Estates residential subdivision located within the East Rift Zone, resulting in lava flowing over streets prompting a mandatory evacuation of the subdivision; and WHEREAS, all information indicates that the current lava flow will continue to advance; and WHEREAS, previous lava flows in the East Rift Zone of Kilauea volcano have caused losses and suffering, including persons being displaced and properties destroyed in the past; ... 4. Sections 127A-12(a)(5) ... the Director of Emergency Management or Administrator of Emergency Management of the Hawai'i Emergency Management Agency are directed to take appropriate actions ...: ... (f) mandatory evacuation of the civilian population." https://governor.Hawai i.gov/wp-content/uploads 2018 05/18-05-03-Lava-Emergency-Proclamation-Lpdf.
- (c) May 30, 2018: Mayor Kim issued a Second Supplementary Emergency Proclamation, declaring in part: "WHEREAS a significant and potentially growing number of residents of Leilani Estates. Lanipuna Gardens, Pohoiki Bay Estates, Kapoho Estates, the greater Kapoho area, and nearby and surrounding areas have been displaced from their residences due to the active lava eruption either permanently or for an unknown duration, as one hundred and twenty eight or more structures have already been destroyed, ... the lava eruption continues to consume more structures ... a state of emergency continues ... effective 30th, May, 2018, and continuing thereon for 60 days or until further act of this office." <a href="http://Hawai.jeoumtymayor.com.2018.05.30.second-supplementary-emergency-proclamation/">http://Hawai.jeoumtymayor.com.2018.05.30.second-supplementary-emergency-proclamation/</a>.
- (d) May 31, 2018: Mayor Kim issued a sixty (60) days Mandatory Evacuation Order "...of all civilians from all that area of Leilani Estates subdivision, including and East of Pomaikai Street, as specifically highlighted and delineated in the map attached hereto..." http://lawai icoumtymayor.com/2018/05/31 mandatory-evacuation-order.
- (e) May 31, 2018: Mayor Kim issued a Mayor Emergency Rule #1 restricting access to the area containing "Kapoho Beach Lots, Vacationland, and Kapoho Farm Lots (hereinafter the "Area"), which is bordered by Kaphoho-Kumukahi Lighthouse Road, Kapoho Kai Road, Kalapana Kapoho Beach Road (Highway 137), and the ocean, and which is shown as the area marked on the map attached hereto. ..." <a href="http://Hawai.icountymayor.com/2018/05/31/mayor-emergency-rule-1/">http://Hawai.icountymayor.com/2018/05/31/mayor-emergency-rule-1/</a>.
- (f) June 14, 2018: Governor Ige transmitted a letter to FEMA requesting funds to combat this emergency. In the letter, the Governor remarked that "since May 28,

- 2018, a total of 24 fissures have opened along a 3.8-mile line through Leilani Estates in the Puna District of Hawai'i County." Further, "[t]he county estimated there are 455 destroyed residential dwellings. They have confirmed that 192 of the destroyed dwellings are primary residences. Additionally, other homes and farms are isolated by twin lava flows extending from the East Rift Zone to the sea." https://governor.llawai'i.gov/wp-content/uploads/2018/06/1806089 -Gov-lee-request-fer-IA Hawai'i-county.pdf.
- (g) June 14, 2018: President Trump amended the federal government's May 11, 2018 Major Disaster Declaration for the State of Hawai'i to designate Hawai'i County specifically. <a href="https://governor.Hawai'i.gov/wp-content/uploads/2018/06/III-4366-FS-REV.pdf">https://governor.Hawai'i.gov/wp-content/uploads/2018/06/III-4366-FS-REV.pdf</a>.
- (h) July 2, 2018: Mayor Kim issued a Third Supplementary Emergency Proclamation suspending the deadlines on applying for homestead exemption and in doing so stated that "the eruption has inundated over 6,000 acres of land and destroyed over 600 structures." This Proclamation also demarcates all areas affected by the eruption as an attachment. <a href="http://lawai'icountymayor.com/2018/07/02">http://lawai'icountymayor.com/2018/07/02</a> third-supplementary-emergency-proclamation/.
- 38. As people throughout the world have become aware through the horrific images of loss and interviews with residents, the East Rift Zone now resembles more of a war zone than a residential neighborhood.
- 39. To date, nearly 800 homes have been lost due to fire or rendered a total loss due to inhabitability and a lack of structural integrity. Residents not only lost their home(s) but many, including the HAYSMERS, lost virtually everything they owned including but not limited to: clothing, furniture, toiletries, food, electronics, tools, machinery, identification, birth records, marriage certificates and other records, photographs, letters, and diplomas. With such catastrophic losses come extreme and debilitating emotional distress, anxiety and sheer panic.
- 40. Despite the catastrophic losses incurred by Puna residents and homeowners, no insurance company has established any physical presence in Puna where people can go to submit forms, discuss their claim, or collect payments due under the policy. Neither

LLOYDS nor any other insurance carrier has established office space or conducted any inperson visits or meetings with their insureds.

41. As more fully described below, Defendants' response to the HAYSMERS' filed claim was to do nothing at all. What these defendants have done to the HAYSMERS and others who have lost their home and belongings amounts to a re-victimization of monumental and unprecedented proportions.

#### V. FACTUAL BACKGROUND

- 42. Plaintiff PHILIP J. HAYSMER is a 77-year-old former resident of Leilani Estates. Mr. Haysmer holds an undergraduate and master's degree in Fine Arts from Michigan State University in East Lansing, Michigan. Mr. Haysmer is a retired art gallery owner who suffers serious and significant health issues.
- 43. Plaintiff LANELL D. HAYSMER is a 70-year-old woman who holds an undergraduate degree in Anthropology from San Jose State University. Mrs. Haysmer is a former resident of Leilani Estates. Like her husband, she suffers from serious and significant health issues.
- 44. On May 2, 2018, Plaintiff LANELL D. HAYSMER suffered a stroke and collapsed into a coma. She was rushed to the intensive care unit at Hilo Memorial Hospital where she remained until she emerged from her coma on May 4, 2018.
- 45. The HAYSMERS resided in their dream home formerly located at 13-3543 Luana Street, Pahoa, District of Puna, Hawai'i County, from on or around April 17, 2012 to May 2, 2018 when they were forced to evacuate following an evacuation proclamation issued by Mayor Harry Kim.

- 46. On May 3, 2018, Plaintiff PHILIP J. HAYSMER learned that their dream home formerly located at 13-3543 Luana Street, Pahoa, was destroyed by fire while his wife lay in a coma at Hilo Memorial Hospital. The fire did not destroy the HAYSMER'S filled water tank.
- 47. The total loss of the HAYSMERS' dwelling due to the peril of fire is a covered occurrence under the INSURANCE POLICY.
- 48. With the exception of the catchment water tank, the HAYSMERS' dwelling and its contents as well as their truck were completely destroyed in the fire. Notably, the HAYSMERS have mitigated their damages as much as humanly possible under their extremely difficult circumstances.
- 49. On or about May 5, 2018, the HAYSMERS filed a total loss claim with their auto insurer, GEICO for the loss of their covered vehicle. Eleven days later, Geico adjuster Mr. Victor Heung, traveled to Pahoa to meet with the HAYSMERS and present them with a total loss check for the HAYSMER'S covered vehicle.
- 50. On May 4, 2018, Plaintiff Philip J. HAYSMER inspected overhead photographs of his land indicating that the lava was flowing in a northeasterly direction away from their property. In one photograph published in the New York Times, charred debris from the PROPERTY can be seen along with the HAYSMERS filled catchment water tank. The PROPERTY was not covered by lava in the overhead photo.
- 51. On May 24, 2018, the HAYSMERS filed a claim for benefits under the INSURANCE POLICY with Aloha Insurance the insurance agent from whom they purchased the INSURANCE POLICY. Defendant MULLEN was assigned by LLOYDS

and/or SPG to adjust the HAYSMER'S claim.

- 52. The HAYSMER'S claim was acknowledged by an email from MULLEN on May 24, 2018.
- 53. On May 24, 2018, James S. Gordon, (who identifies himself as a Senior Adjuster and Investigator at John Mullen & Co., Inc.), confirmed receipt of the May 23, 2018 HAYSMER letter and stated: "[E]mail received and acknowledged, thank you for the very descriptive photo as well. I spoke with Aloha Insurance the first of this week to inform them the initial report had been sent to the carrier and I am currently awaiting further handling instructions. Be safe."
- 54. Over a month after first filing their notice of claim, the HAYSMERS were informed that the claim was now handled by a second claims adjusting firm called Affirmative Risk Assessment (ARM). The HAYSMERS were informed by MULLEN on or about June 27, 2018 that ARM would also be involved with the handling of their claim. The ARM office handling the HAYSMER'S claim is located in the State of Arkansas. To date, no ARM adjusters have established any physical presence on Hawai'i Island.
- 55. Mr. Geoffrey Anderson is an Adjuster with ARM in Little Rock, Arkansas who represented to Plaintiff LANELL D. HAYSMER in a communication from his office in Little Rock on or about June 27, 2018 that Anderson was "acting on behalf of Certain Underwriters at Lloyds." Mr. Anderson also represented to Plaintiff LANELL D. HAYSMER that James S. Gordon was an "Independent Adjuster."
- 56. On June 27, 2018, the HAYSMERS filed a complaint with the DCCA Insurance Division against LLOYDS over the manner in which LLOYDS' was handling

their loss claim.

- 57. By letter dated July 11, 2018, the DCCA Insurance Division acknowledged receipt of the HAYSMERS' complaint and advised the HAYSMERS as follows: "Hawai'i law affords an insurer or licensee up to fifteen working days within which to provide a substantive response to the formal complaints."
- 58. On July 16, 2018, Mr. James S. Gordon sent an email to Plaintiff LANELL D. HAYSMER advising, among other things, that he worked with "an independent adjusting firm charged with collecting the necessary information for the claim and yes a neutral 3<sup>rd</sup> party."
- 59. Mr. Gordon continued in his attempt to describe the role of MULLEN when he states in the July 16, 2018 email: "we were reporting directly to Monarch E & S the broker for your policy who would then report directly to the underwriters at Lloyds. Monarch was overwhelmed due to the volume of lava flow claims and they reached out to Affirmative Risk Management (TPA, third party administrator) who is equipped with the proper staff to handle such an event."
- 60. Mr. Gordon then stated: "Geoff of ARM is the adjuster on the file and reports directly to the underwriters at Lloyds. I have heard from 3 others with the same policy as yours and all 3 have informed me they have yet to receive any denial letter, that tells me something is going on at Lloyds otherwise why hasn't a denial been sent. Hopefully awaiting a positive response. If and when it is sent they will instruct me to close my file. Hope this helps with describing the chain in the claims process."
  - 61. To date, over sixty days since they filed their claim, the HAYSMERS have

not received a substantive response of any kind from the Defendants, nor have they received any benefit, payment, living expenses or a denial of coverage regarding their property loss claim.

- 62. The HAYSMERS have traded their dream home for a single room in a Good Samaritan's garage in Pahoa with their four (4) dogs. They've lost everything. They are in failing health and MULLEN has been advised of their dire situation.
  - 63. To date, the HAYSMERS have received no benefit(s) from the Defendants.
- 64. The HAYSMERS remain in urgent need of financial assistance. The HAYSMERS are barely surviving on their meager fixed income. Since they owned their home outright, there was no monthly mortgage or rent payment. Now, their living expenses have skyrocketed. Not only are the HAYSMERS forced to deal with the emotional distress of losing their home and the uncertainty of where they will live, but the acts and omissions of LLOYDS, MONARCH, SPG and MULLEN in delaying and mishandling the claim have caused the HAYSMERS to experience significant additional stress, anxiety and panic.
- of the Insurance Policy. They have dutifully responded to inquiries and provided detailed information, photographs and documentation to MULLEN in good faith and while in failing health. As noted above, Mrs. Haysmer has been forced to correspond with MULLEN and ARM only days after emerging from a coma. Here we are, over two months since the HAYSMERS submitted their claim, and the HAYSMERS have no more information than they had when they first filed the claim on May 23, 2018.

#### VI. CAUSES OF ACTION

#### CLAIM NO. 1: Breach of Contract

- 66. Plaintiffs re-allege each and every allegation contained in Paragraphs 1 through 65, as if delineated here *in extenso*.
- 67. On the effective date of October 9, 2017, for good and valuable consideration tendered by Plaintiffs PHILIP J. HAYSMER and LANELL D. HAYSMER to, and accepted by, Defendant CERTAIN UNDERWRITERS OF LLOYD'S, LONDON, Defendant LLOYDS issued the INSURANCE POLICY to Plaintiffs that insured the HAYSMERS' home and its contents from loss due to fire. The INSURANCE POLICY remains in effect until October 9, 2018.
- 68. At all times material to this case, the HAYSMERS have complied with their obligations as set forth in the INSURANCE POLICY.
- 69. Between the dates of May 2, 2018 and May 3, 2018, Plaintiffs' dwelling and its contents were destroyed by fire, an insured peril pursuant to the INSURANCE POLICY.
- 70. Based on the total loss, the Plaintiffs submitted a claim for benefits under the INSURANCE POLICY.
- 71. Upon information and belief, the Trade Name "Monarch E & S Insurance Services," which appears prominently on the INSURANCE POLICY as Defendant LLOYDS' correspondent, is wholly owned by Defendant SPG.
- 72. Accordingly, Defendant SPG is a named agent of Defendant LLOYDS in the INSURANCE POLICY.

- 73. Defendant, and Principal, LLOYDS is also vicariously liable for all actions and omissions of its agent, Defendant SPG, that proximately caused the breaches of the terms of the INSURANCE POLICY.
- 74. Defendant MULLEN is an agent of Defendant LLOYDS retained by either Defendant LLOYDS or Defendant SPG to adjust the claim of loss lodged by the HAYSMERS.
- 75. Defendant, and Principal, LLOYDS is also vicariously liable for all actions and omissions of its agent, Defendant MULLEN, that proximately caused the breaches of the terms of the INSURANCE POLICY.
- 76. Defendant LLOYDS has materially breached the terms of the INSURANCE CONTRACT by:
- A. Failing to promptly and reasonably adjust the claim;
- B. Failing to properly train and/or instruct its adjusters and/or agents;
- C. Failing to provide uniform and/or standard guidelines and/or materials to adjusters and/or agents to properly evaluate claims;
- D. Failing to timely provide sufficient funds for the repairs and replacement of the subject property;
- E. Failing to pay for sufficient living expenses incurred by Plaintiffs after they evacuated their insured residence in the time frame of the relevant insurance contract;
- F. Failing to promptly adjust and properly pay the policy limits for the plaintiff's total loss

of their dwelling;

G. Failing to provide sufficient funds for the repair or replacement of the contents contained in the subject property, as per policy provisions; and

- H. Any and all other acts or omissions to be shown at trial on the merits.
- 77. All conditions precedent to the filing of this cause of action have been performed by the HAYSMERS or have been waived by Defendants.
- 78. As a result of the actions and omissions of all Defendants, the Plaintiffs continue to suffer damages.

## CLAIM NO. 2: Breach of Implied Covenant of Good Faith and Fair Dealing

- 79. Plaintiffs re-allege and re-aver each and every allegation contained in Paragraphs 1 through 65, as if delineated here *in extenso*.
- 80. On the effective date of October 9, 2017, for good and valuable consideration tendered by Plaintiffs PHILIP J. HAYSMER and LANELL D. HAYSMER to, and accepted by, Defendant CERTAIN UNDERWRITERS OF LLOYD'S, LONDON, Defendant LLOYDS issued an INSURANCE POLICY to Plaintiffs that covered Plaintiffs' dwelling and its contents until such time as the policy terminates on October 9, 2018.
- 81. At all times material to this case, the HAYMERS have reasonably complied with all terms in the INSURANCE POLICY.
- 82. Between the dates of May 2, 2018 and May 3, 2018, the HAYSMERS dwelling and its contents were destroyed by fire, which is an insured peril pursuant to the

#### INSURANCE POLICY.

- 83. Consequently, Plaintiffs lodged a claim for their losses as reasonably accordant to their responsibilities under the INSURANCE POLICY.
- 84. Aside from the contractual duties owed to Plaintiffs by Defendant LLOYDS, and pursuant to *Best Place, Inc. v. Penn America Insurance Co.*, 920 P.2d 334 (1996), Defendant LLOYDS also owed Plaintiffs an implied duty of good faith and fair dealing in its conduct relative to the handling of the loss claim lodged by Plaintiffs.
- 85. The enumerated proscribed insurance practices found in HI Rev Stat Sec 413:13-103 (2017) may serve as evidence of unreasonable conduct by an insurer.
- 86. Upon information and belief, the Trade Name "Monarch E & S Insurance Services," which appears prominently on the INSURANCE POLICY as Defendant LLOYDS correspondent, is wholly owned by Defendant SPG.
  - 87. Accordingly, Defendant SPG is an agent of Defendant LLOYDS.
- 88. Defendant SPG is independently liable for its actions and omissions that proximately caused the breach of the duty of good faith and fair dealing.
- 89. Defendant SPG is also vicariously liable for all actions and omissions of its principal, Defendant LLOYDS, which proximately caused the breach of the duty of good faith and fair dealing.
- 90. Upon information and belief, Defendant MULLEN is an agent of Defendant LLOYDS retained by either Defendant LLOYDS or Defendant SPG to adjust the claim of loss lodged by Plaintiffs.

- 91. Defendant MULLEN is independently liable for its actions and omissions that proximately caused the breach of the duty of good faith and fair dealing.
- 92. Defendant MULLEN is also vicariously liable for all actions and omissions of its principal, Defendant LLOYDS, which proximately caused the breach of the implied duty of good faith and fair dealing.
- 93. Defendants LLOYDS, SPG, and MULLEN, materially breached their duty of good faith and fair dealing to the HAYSMERS by:
  - (A) Misrepresenting pertinent facts or insurance policy provisions relating to coverages at issue;
  - (B) With respect to claims arising under its policies, failing to respond with reasonable promptness, in no case more than fifteen working days, to communications received from: (i) The insurer's policyholder; (ii) Any other persons, including the commissioner; or (iii) The insurer of a person involved in an incident in which the insurer's policyholder is also involved. The response shall be more than an acknowledgment that such person's communication has been received, and shall adequately address the concerns stated in the communication;
  - (C) Failing to adopt and implement reasonable standards for the prompt investigation of claims arising under insurance policies;
  - (D) Failing to affirm or deny coverage of claims within a reasonable time after proof of loss statements have been completed;
  - (E) Failing to provide the insured, or when applicable the insured's beneficiary, with a reasonable written explanation for any delay, on every claim remaining unresolved for thirty calendar days from the date it was reported;
  - (F) Not attempting in good faith to effectuate prompt, fair, and equitable settlements of claims in which liability has become reasonably clear;
  - (G) Compelling insureds to institute litigation to recover amounts due under an insurance policy by not investigating the claim in a reasonably prompt manner to the detriment of the insureds thus compelling them to seek judicial intervention; and

- (H) Failing to promptly settle claims, where liability has become reasonably clear, under one portion of the insurance policy coverage to influence settlements under other portions of the insurance policy coverage.
- (I) Failing to issue a property insurance contract to insureds that contained exclusionary language that is narrowly drafted;
- (J) Failing to issue a property insurance contract to insureds that contained exclusionary language that was defined within the agreement;
- (K) Failing to issue a property insurance contract to insureds that is not designed to be used to deny coverage for the cost of repairs and restoration of plaintiffs' property as a result of the damages arising from an occurrence or covered peril as defined in the policy;
- (L) Failing to provide a property insurance contract that is unambiguous;
- (M) The Defendants failure and/or omissions constitute bad faith in that they were arbitrary and capricious, all of which entitles Plaintiffs to recover attorney's fees, costs and penalties as allowed by law; and
- (N) Any other acts or omissions to be shown at trial on the merits.
- 94. All conditions precedent to the filing of this cause of action have been performed or have been waived by Defendants.
- 95. As a result of the actions and omissions of all Defendants, the Plaintiffs continue to suffer damages.
- 96. Defendants failures were willful and/or intentional and/or arbitrary and capricious so that the Plaintiffs are entitled to an award of penalties, attorney's fees and costs.

## CLAIM NO. 3: Violation of Deceptive Practices Act Under HI Stat Sec 480:13 (2017)

97. Plaintiffs re-allege and re-aver each and every allegation contained in Paragraphs 1 through 65, 80 through 96, as if delineated here *in extenso*.

- 98. Plaintiffs are "consumers" as that term is defined in HI Rev Sec. 480-1 (2017).
- 99. Unfair or deceptive acts or practices in the conduct of any trade or commerce are unlawful. HI Rev Sec 480-2 (2017).
- 100. Consumers may bring an action against insurance companies and adjusters who engage in unfair or deceptive acts or practices in the conduct of their business. HI Rev Sec 480-2(d) (2017).
- 101. The court may award additional civil remedies if a person who commits a violation of HI Rev Stat Sec 480-2 (2017) directs, targets, or injures an elder, defined as a person over the age of 62 years of age. In addition to any other civil penalty, the court may impose a civil remedy not to exceed \$10,000 for each violation. HI Stat Sec 480-13.5(a) (2017).
  - 102. Plaintiffs are both over 70 years of age.
- 103. The court may award a prevailing plaintiff a sum not less than \$1,000 or threefold damages by the plaintiff sustained, whichever sum is greater, and reasonable attorney fees together with the costs of suit; provided that where the plaintiff is an elder, the plaintiff, in the alternative, may be awarded a sum not less than \$5,000 or threefold damages sustained by the plaintiff, whichever sum is greater, and reasonable attorney's fees together with costs of suit. HI Rev Stat Sec 480-13(2)(b) (2017).
- 104. Upon information and belief, and at all times material to this case, Defendant LLOYDS, was not authorized to transact business in insurance in the State.

- 105. HI Rev Stat Sec 431:8-201 (2017) prohibits insurers from transacting an insurance business in the State without a certificate of authority.
- 106. At all times relevant to this case, Defendant SPG acted as an agent for Defendant LLOYDS in procuring Plaintiffs' insurance transaction that resulted in the INSURANCE POLICY.
- 107. Upon information and belief, and at all times relevant to this case, Defendant MULLEN acted as an agent for Defendant LLOYDS in serving as the adjuster for the Plaintiffs' claim of loss filed pursuant to the INSURANCE POLICY.
- 108. HI Rev Stat Sec 431:8-202 (2017) prohibits all persons from aiding an unauthorized insurer, including producers and adjusters.
- 109. Based on all allegations contained in this count, Defendants LLOYDS, SPG, and MULLEN, have engaged in unfair or deceptive acts or practices in violation of violated HI Stat Sec 480-2 (2017).
- 110. Specifically, although not the only instance of misconduct, Defendant LLOYDS has engaged in an unfair or deceptive acts or practices by transacting insurance business without first obtaining a certificate of authority in violation of HI Stat Sec 431:8-201 (2017).
- 111. Specifically, although not the only instance of misconduct, Defendant SPG has engaged in an unfair or deceptive acts or practices by aiding an unauthorized insurer like Defendant LLOYDS in violation of HI Stat Sec 431:8-202 (2017).
  - 112. Specifically, although not the only instance of misconduct, Defendant SPG

has engaged in an unfair or deceptive acts or practices by aiding an unauthorized insurer like Defendant LLOYDS in violation of HI Stat Sec 431:8-202 (2017).

113. As a result of the Defendants conduct in willfully engaging in unfair or deceptive acts and practices targeting the elder Plaintiffs, the Plaintiffs continue to suffer damages.

#### CLAIM NO. 4: Civil Conspiracy

- 114. Plaintiffs re-allege and re-aver each and every allegation contained in Paragraphs 1 through 113, as if delineated here *in extenso*.
- 115. Upon information and belief, Defendant SPECIALTY PROGRAM GROUP, INC., through trade name "Monarch E & S Insurance Services," acted, at all times relevant to this case, as an agent for its Principal, Defendant CERTAIN UNDERWRITERS AT LLOYD'S, LONDON, and did so within the scope of such agency.
- 116. Upon information and belief, Defendant JOHN MULLEN & CO., INC. acted, at all times relevant to this case, as an agent for its Principal, Defendant CERTAIN UNDERWRITERS AT LLOYD'S, LONDON, and/or its Principal, Defendant SPECIALTY PROGRAM GROUP, INC., and did so within the scope of its agency.
- 117. From on or about May 3, 2018 to the present, LLOYDS, SPG, and MULLEN, have knowingly and willfully conspired and agreed among themselves to deprive Plaintiffs PHILLIP J. HAYSMER and LANELL D. HAYSMER of the benefit of their coverage under the INSURANCE POLICY.
  - 118. At all times relevant to this case, Defendants LLOYDS, SPG, and

MULLEN have each conducted themselves in a manner so as to proximately cause a breach of the implied duty of good faith and fair dealing and to violate HI Stat Sec 480-2 (2017), as alleged in the above factual allegations contained in this Complaint for Damages, pursuant to, and in furtherance of, the conspiracy and alleged agreement to conspire.

- 119. Defendant SPG furthered the conspiracy by lending aid and encouragement to the other Defendants, and by ratifying and adopting the acts of the other Defendants.
- 120. Defendant MULLEN furthered the conspiracy by lending aid and encouragement to the other Defendants, and by ratifying and adopting the acts of the other Defendants.
- 121. Defendant LLOYDS furthered the conspiracy by lending aid and encouragement to the other Defendants, and by ratifying and adopting the acts of the other Defendants.
- 122. As a proximate cause of the wrongful actions or omissions committed by Defendants, Plaintiffs have been generally damaged in the sum that exceeds \$40,000 but that cannot yet be precisely calculated because Plaintiffs continue to suffer damages every moment that Defendants have willfully conspired and agreed among themselves to deprive Plaintiffs PHILLIP J. HAYSMER and LANELL D. HAYSMER of the benefit of their coverage under the INSURANCE POLICY.
- 123, All Defendants have and continue to conduct themselves maliciously and to oppress Plaintiffs.

#### PRAYER FOR RELIEF

WHEREFORE, Plaintiffs are entitled to not only the payment under the INSURANCE POLICY of any and all coverages insuring the PROPERTY as well as personal property and all other coverages under the INSURANCE POLICY for the damage and/or total loss to Plaintiffs' insured residence and property caused by the covered peril of fire, but also to a claims process that is unencumbered by delay. Plaintiff's respectfully pray for the following relief to include but not be limited to:

- A. Damages against Defendant LLOYDS, including attorney's fees, court costs and any other damages incurred by Plaintiffs as a result of the Defendant's breach of the terms in the INSURANCE POLICY;
- B. Damages against Defendants LLOYDS, SPG, and MULLEN, including attorney's fees, court costs and any other damages, to include punitive damages, incurred by Plaintiffs as a result of the Defendants' breach of the covenant of good faith and fair dealing;
- C. Damages against Defendants LLOYDS, SPG, and MULLEN, including attorney's fees, court costs and any other damages incurred by Plaintiffs as a result of the Defendants' violation of the deceptive practices act as expressed in HI Stat Sec 480-13;
- D. Damages against Defendants LLOYDS, SPG, and MULLEN, including attorney's fees, court costs and any other damages incurred by Plaintiffs as a result of the Defendants' conspiracy to deprive Plaintiffs of the benefits of coverage under the INSURANCE POLICY.
- E. Court costs, expenses, and judicial interest; and
- F. Any and all other equitable relief deemed appropriate by this Court.

#### JURY DEMAND

Plaintiffs respectfully pray for a trial by jury of all claims.

WHEREFORE, Plaintiffs, PHILIP J. HAYSMER and LANELL D. HAYSMER, respectfully pray after due proceedings be had that there be a judgment entered in their favor and against Defendants awarding damages, prejudgment interest, post judgment interest, attorney's fees and costs, punitive and/or exemplary damages as may be allowed by law and for further relief as equity and justice require.

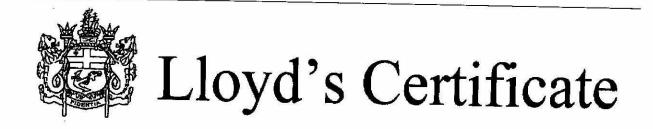

# NUCLEAR ENERGY LIABILITY EXCLUSION (BROAD FORM)

It is agreed that:

- This policy does not apply:
  - A. Under any Liability Coverage, to bodily injury or property damagege
    - (1) with respect to which an **insured** under this policy is also an insured under a nuclear energy liability policy issued by Nuclear Energy Liability Insurance Association, Mutual Atomic Energy Liability Underwriters or Nuclear Insurance Association of Canada, or would be an insured under any such policy but for its termination upon exhaustion of its limit of liability; or

    - the nuclear material (a) is at any nuclear facility owned by, or operated by or on behalf of, an insured or (b) has been discharged or dispersed therefrom:
    - (2) the nuclear material is contained in spent fuel or waste at any time possessed, handled, used, possessed, stores, transported or disposed of by or on behalf of an insured; or
    - (3) the bodily injury or property damage arising out of the furnishing by an insured of services, materials, parts or equipment in connection with the lanning, construction, maintenance, operations or use of any nuclear facility, but if such facility is located within the United States of America, its territories or possessions or canada, this exclusion (3) applies only to property damage to such nuclear facility and any property thereat.

- (c) any equipment or device used for the processing, fabricating or alloying of special nuclear material if at any time the total amount of such material in the custody of the insured at the premises where such equipment or device is located consists of or contains more than 25 grams of plutonium or uranium 233 or any combination thereof, or more than 250 grams of uranium 235.
- (d) any structure, basin, excavation, premises or place prepared or used for the storage or disposal of waste.

Payment or tender of any unearned premium by the Underwriters shall not be a condition precedent to the effectiveness of Cancellation but such payment shall be made as soon as practicable.

If the period of limitation relating to the giving of notice is prohibited or made void by any law controlling the construction thereof, such period shall be deemed to be amended so as to be equal to the minimum period of limitation permitted by such law.

The term 'any kind of seepage or any kind of pollution and/or contamination' as used in this Endorsement includes (but is not limited to):

- a) seepage of, or pollution and/or contamination by, anything, including but not limited to, any material designated as a 'hazardous substance' by the United States Environmental Protection Agency or as a 'hazardous material' by the United States Department of Transportation, or defined as a 'toxic substance' by the Canadian Environmental Protection Act for the purposes of Part II of the Act, or any substance designated or defined as toxic, dangerous, hazardous or deleterious to persons or the environment under any other Federal, State, Provincial, Municipal or other law, ordinance or regulation; and
- b) the presence, existence, or release of anything which endangers or threatens to endanger the health, safety or welfare of persons or the environment.

## DEBRIS REMOVAL ENDORSEMENT

    - b. For the purpose of this definition:
      - (1) Aircraft means any contrivance used or designed for flight, except model or hobby aircraft not used or designed to carry people or cargo;

      - (3) Watercraft means a craft principally designed to be propelled on or in water by wind, engine power or electric motor;

- "Insured" means:
  - You and residents of your household who
    - (1) Your relatives; or
    - (2) Other persons under the age of 21 and in the care of any person named above;
  - A student enrolled in school full time, as defined by the school, who was a resident of your household before moving out to attend school, provided the student is under the age
    - (1) 24 and your relative; or
    - (2) 21 and in your care or the care of a person described in a.(1) above; or

#### c. Under Section II:

- (1) With respect to animals or watercraft to which this policy applies, any per-son or organization legally responsible for these animals or watercraft which are owned by you or any person included in a. or b. above.   - a. An employee of an "insured", or an em-ployee leased to an "insured" by a labor leasing firm, under an agreement between an "insured" and the labor leasing firm, whose duties are related to the maintenance or use of the "residence premises", including household or domestic services; or
  - One who performs similar duties else-where not related to the "business" of an "insured".

A "residence employee" does not include a temporary employee who is furnished to an "insured" to substitute for a permanent "residence employee" on leave or to meet seasonal or short-term workload conditions.

- 11. "Residence premises" means:
  - a. The one family dwelling where you reside;
  - The two, three or four family dwelling where you reside in at least one of the family units;
  - c. That part of any other building where you reside:

and which is shown as the "residence premises" in the Declarations.

"Residence premises" also includes other structures and grounds at that location.

#### **DEDUCTIBLE**

Unless otherwise noted in this policy, the following deductible provision applies:

Subject to the policy limits that apply, we will pay only that part of the total of all loss payable under Section I that exceeds the deductible amount shown in the Declarations

#### SECTION I - PROPERTY COVERAGES

#### A. Coverage A - Dwelling

- 1. We cover:
  - a. The dwelling on the "residence premises" shown in the Declarations, including structures attached to the dwelling; and
  - b. Materials and supplies located on or next to the "residence premises" used to con-struct, alter or repair the dwelling or other structures on the "residence premises".
- We do not cover land, including land on which the dwelling is located.

#### B. Coverage B - Other Structures

We cover other structures on the "residence premises" set apart from the dwelling by clear space.
 This includes structures connected to the dwelling by only a fence, utility line, or similar connection.

#### 2. We do not cover:

- Land, including land on which the other structures are located;
- Other structures rented or held for rental to any person not a tenant of the dwelling, unless used solely as a private garage;
- Other structures from which any "business" is conducted; or
- d. Other structures used to store "business" property. However, we do cover a struc-ture that contains "business" property solely owned by an "insured" or a tenant of the dwelling provided that "business" property does not include gaseous or liquid fuel, other than fuel in a permanently installed fuel tank of a vehicle or craft parked or stored in the structure.
- The limit of liability for this coverage will not be more than 10% of the limit of liability that applies to Coverage A. Use of this coverage does not reduce the Coverage A limit of liability.

#### C. Coverage C - Personal Property

#### 1. Covered Property

We cover personal property owned or used by an "insured" while it is anywhere in the world. After a loss and at your request, we will cover personal property owned by:

- Others while the property is on the part of the "residence premises" occupied by an "insured": or
- A guest or a "residence employee", while the property is in any residence occupied by an "insured".

#### 2. Limit For Property At Other Residences

Our limit of liability for personal property usually located at an "insured's" residence, other than the "residence premises", is 10% of the limit of liability for Coverage C, or \$1,000, whichever is greater. However, this limitation does not apply to personal property:

- Moved from the "residence premises" because it is being repaired, renovated or rebuilt and is not fit to live in or store property in; or
- b. In a newly acquired principal residence for 30 days from the time you begin to move the property there.

#### 3. Special Limits Of Liability

The special limit for each category shown below is the total limit for each loss for all property in that category. These special limits do not increase the Coverage C limit of liability.

- \$200 on money, bank notes, bullion, gold other than goldware, silver other than sil-verware, platinum other than platinum-ware, coins, medals, scrip, stored value cards and smart cards.
- b. \$1,500 on securities, accounts, deeds, evidences of debt, letters of credit, notes other than bank notes, manuscripts, personal records, passports, tickets and stamps. This dollar limit applies to these categories regardless of the medium (such as paper or computer software) on which the material exists.

This limit includes the cost to research, replace or restore the information from the lost or damaged material.

- \$1,500 on watercraft of all types, including their trailers, furnishings, equipment and outboard engines or motors.
- d. \$1,500 on trailers or semitrailers not used with watercraft of all types.
- \$1,500 for loss by theft of jewelry, watches, furs, precious and semiprecious stones.
- f. \$2,500 for loss by theft of firearms and related equipment.
- g. \$2,500 for loss by theft of silverware, silver-plated ware, goldware, gold-plated ware, platinumware, platinum-plated ware and pewterware. This includes flatware, hollowware, tea sets, trays and trophies made of or including silver, gold or pewter.
- \$2,500 on property, on the "residence premises", used primarily for "business" purposes.
- \$500 on property, away from the "residence premises", used primarily for "business" purposes. However, this limit does not apply to loss to electronic apparatus and other property described in Categories j. and k. below.
- j. \$1,500 on electronic apparatus and accessories, while in or upon a "motor vehicle", but only if the apparatus is equipped to be operated by power from the "motor vehicle's" electrical system while still capable of being operated by other power sources.
  - Accessories include antennas, tapes, wires, records, discs or other media that can be used with any apparatus described in this Category j.
- k. \$1,500 on electronic apparatus and accessories used primarily for "business" while away from the "residence premises" and not in or upon a "motor vehicle". The apparatus must be equipped to be operated by power from the "motor vehicle's" electrical system while still capable of being operated by other power sources.

Accessories include antennas, tapes, wires, records, discs or other media that can be used with any apparatus described in this Category k.

## 4. Property Not Covered

We do not cover:

 Articles separately described and specifi-cally insured, regardless of the limit for which they are insured, in this or other in-surance;

- b. Animals, birds or fish;
- "Motor vehicles",
  - (1) This includes:
    - (a) Their accessories, equipment and parts; or
    - (b) Electronic apparatus and acces-sories designed to be operated solely by power from the electrical system of the "motor vehicle". Accessories include antennas, tapes, wires, records, discs or other media that can be used with any apparatus described above.

The exclusion of property described in (a) and (b) above applies only while such property is in or upon the "motor vehicle".

- (2) We do cover "motor vehicles" not required to be registered for use on public roads or property which are:
  - (a) Used solely to service an "insured's" residence; or
  - (b) Designed to assist the handi-capped;
- d. Aircraft meaning any contrivance used or designed for flight including any parts whether or not attached to the aircraft.
  - We do cover model or hobby aircraft not used or designed to carry people or cargo;
- Hovercraft and parts. Hovercraft means a self-propelled motorized ground effect vehicle and includes, but is not limited to, flarecraft and air cushion vehicles:
- f. Property of roomers, boarders and other tenants, except property of roomers and boarders related to an "insured";
- g. Property in an apartment regularly rented or held for rental to others by an "insured", except as provided under E.10. Landlord's Furnishings under Section I - Property Coverages;
- Property rented or held for rental to others off the "residence premises";
- "Business" data, including such data stored in:
  - Books of account, drawings or other paper records; or
  - (2) Computers and related equipment.

We do cover the cost of blank recording or storage media, and of prerecorded computer programs available on the retail market;

- Credit cards, electronic fund transfer cards or access devices used solely for deposit, withdrawal or transfer of funds except as provided in E.6. Credit Card, Electronic Fund Transfer Card Or Access Device, Forgery And Counterfeit Money under Section I -Property Coverages; or
- k. Water or steam.

## D. Coverage D - Loss Of Use

The limit of liability for Coverage D is the total limit for the coverages in 1. Additional Living Expense, 2. Fair Rental Value and 3. Civil Authority Prohibits Use below.

## 1. Additional Living Expense

If a loss covered under Section I makes that part of the "residence premises" where you reside not fit to live in, we cover any necessary increase in living expenses incurred by you so that your household can maintain its normal standard of living.

Payment will be for the shortest time required to repair or replace the damage or, if you permanently relocate, the shortest time required for your household to settle elsewhere.

#### 2. Fair Rental Value

If a loss covered under Section I makes that part of the "residence premises" rented to others or held for rental by you not fit to live in, we cover the fair rental value of such premises less any expenses that do not continue while it is not fit to live in.

Payment will be for the shortest time required to repair or replace such premises.

#### 3. Civil Authority Prohibits Use

If a civil authority prohibits you from use of the "residence premises" as a result of direct damage to neighboring premises by a Peril Insured Against, we cover the loss as provided in 1. Additional Living Expense and 2. Fair Rental Value above for no more than two weeks.

#### 4. Loss Or Expense Not Covered

We do not cover loss or expense due to cancellation of a lease or agreement.

The periods of time under 1. Additional Living Expense, 2. Fair Rental Value and 3. Civil Authority Prohibits Use above are not limited by expiration of this policy.

#### E. Additional Coverages

## 1. Debris Removal

We will pay your reasonable expense for the removal of:

- Debris of covered property if a Peril Insured Against that applies to the damaged property causes the loss; or
- (2) Ash, dust or particles from a volcanic eruption that has caused direct loss to a building or property contained in a building.

This expense is included in the limit of liability that applies to the damaged property. If the amount to be paid for the actual damage to the property plus the debris removal expense is more than the limit of liability for the damaged property, an additional 5% of that limit is available for such expense.

- b. We will also pay your reasonable expense, up to \$1,000, for the removal from the "residence premises" of:
  - Your tree(s) felled by the peril of Windstorm or Hail or Weight of Ice, Snow or Sleet; or
  - (2) A neighbor's tree(s) felled by a Peril Insured Against under Coverage C;

provided the tree(s):

- (3) Damage(s) a covered structure; or
- (4) Does not damage a covered structure, but:
  - (a) Block(s) a driveway on the "residence premises" which prevent(s) a "motor vehicle", that is registered for use on public roads or property, from entering or leaving the "residence premises"; or
  - (b) Block(s) a ramp or other fixture designed to assist a handicapped person to enter or leave the dwelling building.

The \$1,000 limit is the most we will pay in any one loss regardless of the number of fallen trees. No more than \$500 of this limit will be paid for the removal of any one tree.

This coverage is additional insurance.

## 2. Reasonable Repairs

a. We will pay the reasonable cost incurred by you for the necessary measures taken solely to protect covered property that is damaged by a Peril Insured Against from further damage.

- b. If the measures taken involve repair to other damaged property, we will only pay if that property is covered under this policy and the damage is caused by a Peril Insured Against. This coverage does not:
  - Increase the limit of liability that applies to the covered property; or
  - (2) Relieve you of your duties, in case of a loss to covered property, described in B.4. under Section 1 - Conditions.

## 3. Trees, Shrubs And Other Plants

We cover trees, shrubs, plants or lawns, on the "residence premises", for loss caused by the following Perils Insured Against:

- a. Fire or Lightning;
- b. Explosion;
- c. Riot or Civil Commotion;
- d. Aircraft:
- Vehicles not owned or operated by a resident of the "residence premises";
- f. Vandalism or Malicious Mischief; or
- g. Theft.

We will pay up to 5% of the limit of liability that applies to the dwelling for all trees, shrubs, plants or lawns. No more than \$500 of this limit will be paid for any one tree, shrub or plant. We do not cover property grown for "business" purposes.

This coverage is additional insurance.

## 4. Fire Department Service Charge

We will pay up to \$500 for your liability assumed by contract or agreement for fire department charges incurred when the fire department is called to save or protect covered property from a Peril Insured Against. We do not cover fire department service charges if the property is located within the limits of the city, municipality or protection district furnishing the fire department response.

This coverage is additional insurance. No deductible applies to this coverage.

#### 5. Property Removed

We insure covered property against direct loss from any cause while being removed from a premises endangered by a Peril Insured Against and for no more than 30 days while removed.

This coverage does not change the limit of liability that applies to the property being removed.

## 6. Credit Card, Electronic Fund Transfer Card Or Access Device, Forgery And Counterfeit Money

- a. We will pay up to \$500 for:
  - The legal obligation of an "insured" to pay because of the theft or unauthor-ized use of credit cards issued to or registered in an "insured's" name:
  - (2) Loss resulting from theft or unauthorized use of an electronic fund transfer card or access device used for deposit, withdrawal or transfer of funds, issued to or registered in an "insured's" name:
  - (3) Loss to an "insured" caused by forgery or alteration of any check or negotiable instrument; and
  - (4) Loss to an "insured" through accep-tance in good faith of counterfeit United States or Canadian paper cur-rency.

All loss resulting from a series of acts committed by any one person or in which any one person is concerned or implicated is considered to be one loss.

This coverage is additional insurance. No deductible applies to this coverage.

- b. We do not cover:
  - Use of a credit card, electronic fund transfer card or access device;
    - (a) By a resident of your household:
    - (b) By a person who has been en-trusted with either type of card or access device; or
    - (c) If an "insured" has not complied with all terms and conditions un-der which the cards are issued or the devices accessed; or
  - (2) Loss arising out of "business" use or dishonesty of an "insured".
- If the coverage in a above applies, the following defense provisions also apply:
  - (1) We may investigate and settle any claim or suit that we decide is appro-priate. Our duty to defend a claim or suit ends when the amount we pay for the loss equals our limit of liability.
  - (2) If a suit is brought against an "insured" for liability under a.(1) or (2) above, we will provide a defense at our expense by counsel of our choice.
  - (3) We have the option to defend at our expense an "insured" or an "insured's" bank against any suit for the enforcement of payment under

#### 7. Loss Assessment

- a. We will pay up to \$1,000 for your share of loss assessment charged during the policy period against you, as owner or tenant of the "residence premises", by a corportion or association of property owners. The assessment must be made as a result of direct loss to property, owned by all members collectively, of the type that would be covered by this policy if owned by you, caused by a Peril Insured Against under Coverage A, other than:
- (1) Earthquake; or
- (2) Land shock waves or tremors before, during or after a volcanic eruption.

The limit of \$1,000 is the most we will pay with respect to any one loss, regardless of the number of assessments. We will only apply one deductible, per unit, to the total amount of any one loss to the property described above, regardless of the number of assessments.

- We do not cover assessments charged against you or a corporation or association of property owners by any governmental body.
- Paragraph P. Policy Period under Section 1 -Conditions does not apply to this coverage.

### 8. Collapse

- a. With respect to this Additional Coverage:
  - Collapse means an aburpt falling down or caving in of a building or any part of a building with the result that the building or part of the building can not be occupied for its current intended purpose.
  - (2) A building or any part of a building that is in danger of falling down or caving in is not considered to be in a state of collarse.
  - (3) A part of a building that is standing is not considered to be in a state of collapse even if it has separated from another part of the building.
  - (4) A building or any part of a building that is standing is not considered to be in a state of collapse even if it shows evidence of cracking, bulging, sagging, bending, leaning, settling, shrinkage or expansion.

- b. We insure for direct physical loss to cov-ered property involving collapse of a building or any part of a building if the collapse was caused by one or more of the following:
  - The Perils Insured Against named under Coverage C;
  - (2) Decay that is hidden from view, unless the presence of such decay is known to an "insured" prior to collapse;
  - (3) Insect or vermin damage that is hid-den from view, unless the presence of such damage is known to an "insured" prior to collapse;
  - (4) Weight of contents, equipment, animals or people;
  - (5) Weight of rain which collects on a roof; or
  - (6) Use of defective material or methods in construction, remodeling or reno-vation if the collapse occurs during the course of the construction, remodeling or renovation.
- c. Loss to an awning, fence, patio, deck, pavement, swimming pool, underground pipe, flue, drain, cesspool, septic tank, foundation, retaining wall, bulkhead, pier, wharf or dock is not included under b.(2) through (6) above, unless the loss is a direct result of the collapse of a building or any part of a building.
- This coverage does not increase the limit of liability that applies to the damaged covered property.

### 9. Glass Or Safety Glazing Material

- a. We cover:
  - The breakage of glass or safety glazing material which is part of a covered building, storm door or storm window;
  - (2) The breakage of glass or safety glazing material which is part of a covered building, storm door or storm window when caused directly by earth movement; and
  - (3) The direct physical loss to covered property caused solely by the pieces, fragments or splinters of broken glass or safety glazing material which is part of a building, storm door or storm window.

- b. This coverage does not include loss:
  - To covered property which results because the glass or safety glazing material has been broken, except as provided in a.(3) above; or
  - (2) On the "residence premises" if the dwelling has been vacant for more than 60 consecutive days immediately before the loss, except when the breakage results directly from earth movement as provided in a.(2) above. A dwelling being constructed is not considered vacant.
- This coverage does not increase the limit of liability that applies to the damaged property.

### 10. Landlord's Furnishings

We will pay up to \$2,500 for your appliances, carpeting and other household furnishings, in each apartment on the "residence premises" regularly rented or held for rental to others by an "insured", for loss caused by a Peril Insured Against in Coverage C, other than Theft.

This limit is the most we will pay in any one loss regardless of the number of appliances, carpeting or other household furnishings involved in the loss.

This coverage does not increase the limit of liability applying to the damaged property.

### 11. Ordinance Or Law

- a. You may use up to 10% of the limit of liability that applies to Coverage A for the increased costs you incur due to the en-forcement of any ordinance or law which requires or regulates:
  - The construction, demolition, remodeling, renovation or repair of that part of a covered building or other structure damaged by a Peril Insured Against;
  - (2) The demolition and reconstruction of the undamaged part of a covered building or other structure, when that building or other structure must be totally demolished because of damage by a Peril Insured Against to another part of that covered building or other structure; or
  - (3) The remodeling, removal or replace-ment of the portion of the undamaged part of a covered building or other structure necessary to complete the remodeling, repair or replacement of that part of the covered building or other structure damaged by a Peril Insured Against.

b. You may use all or part of this ordinance or law coverage to pay for the increased costs you incur to remove debris resulting from the construction, demolition, remodeling, renovation, repair or replacement of property as stated in a. above.

#### c. We do not cover:

- The loss in value to any covered building or other structure due to the requirements of any ordinance or law; or
- (2) The costs to comply with any ordi-nance or law which requires any "insured" or others to test for, monitor, clean up, remove, contain, treat, detoxify or neutralize, or in any way respond to, or assess the effects of, pollutants in or on any covered build-ing or other structure.

Pollutants means any solid, liquid, gaseous or thermal irritant or contaminant, including smoke, vapor, soot, fumes, acids, alkalis, chemicals and waste. Waste includes materials to be recycled, reconditioned or reclaimed.

This coverage is additional insurance.

#### 12. Grave Markers

We will pay up to \$5,000 for grave markers, including mausoleums, on or away from the "residence premises" for loss caused by a Peril Insured Against under Coverage C.

This coverage does not increase the limits of liability that apply to the damaged covered property.

#### SECTION I - PERILS INSURED AGAINST

## A. Coverage A - Dwelling And Coverage B - Other Structures

- I. We insure against risk of direct physical loss to property described in Coverages A and B.
- We do not insure, however, for loss:
  - a. Excluded under Section I Exclusions;
  - Involving collapse, except as provided in E.8.
     Collapse under Section I Property Coverages; or
  - c. Caused by:
    - (1) Freezing of a plumbing, heating, air conditioning or automatic fire protective sprinkler system or of a household appliance, or by discharge, leakage or overflow from within the system or appliance caused by freezing. This provision does not apply if you have used reasonable care to:
      - (a) Maintain heat in the building; or

(b) Shut off the water supply and drain all systems and appliances of water.

However, if the building is protected by an automatic fire protective sprinkler system, you must use reasonable care to continue the water supply and maintain heat in the building for coverage to apply.

- (2) Freezing, thawing, pressure or weight of water or ice, whether driven by wind or not, to a:
  - (a) Fence, pavement, patio or swimming pool;
  - (b) Footing, foundation, bulkhead, wall, or any other structure or device that supports all or part of a building, or other structure;
  - (c) Retaining wall or bulkhead that does not support all or part of a building or other structure; or
  - (d) Pier, wharf or dock:
- (3) Theft in or to a dwelling under construction, or of materials and supplies for use in the construction until the dwelling is finished and occupied;
- (4) Vandalism and malicious mischief, and any ensuing loss caused by any intentional and wrongful act commit-ted in the course of the vandalism or malicious mischief, if the dwelling has been vacant for more than 60 consecutive days immediately before the loss. A dwelling being constructed is not considered vacant;
- (5) Mold, fungus or wet rot. However, we do insure for loss caused by mold, fungus or wet rot that is hidden within the walls or ceilings or beneath the floors or above the ceilings of a structure if such loss results from the accidental discharge or overflow of water or steam from within:
  - (a) A plumbing, heating, air conditioning or automatic fire protective sprinkler system, or a household appliance, on the "residence premises"; or

(b) A storm drain, or water, steam or sewer pipes, off the "residence premises".

For purposes of this provision, a plumbing system or household appliance does not include a sump, sump pump or related equipment or a roof drain, gutter, downspout or similar fixtures or equipment; or

- (6) Any of the following:
  - (a) Wear and tear, marring, deterioration;
  - Mechanical breakdown, latent defect, inherent vice, or any quality in property that causes it to damage or destroy itself;
  - (c) Smog, rust or other corrosion, or dry rot;
  - (d) Smoke from agricultural smudg-ing or industrial operations:
  - (e) Discharge, dispersal, seepage, migration, release or escape of pollutants unless the discharge, dispersal, seepage, migration, release or escape is itself caused by a Peril Insured Against named under Coverage C.

Pollutants means any solid, liquid, gaseous or thermal irritant or contaminant, including smoke, vapor, soot, fumes, acids, alkalis, chemicals and waste. Waste includes materials to be recycled, reconditioned or reclaimed;

- (f) Settling, shrinking, bulging or expansion, including resultant cracking, of bulkheads, pave-ments, patios, footings, founda-tions, walls, floors, roofs or ceilings;
- (g) Birds, vermin, rodents, or insects; or
- (h) Animals owned or kept by an "insured".

#### Exception To c.(6)

Unless the loss is otherwise excluded, we cover loss to property covered under Coverage A or B resulting from an accidental discharge or overflow of water or steam from within a:

(i) Storm drain, or water, steam or sewer pipe, off the "residence premises"; or

(ii) Plumbing, heating, air conditioning or automatic fire protective sprinkler system or household appliance on the "residence premises". This includes the cost to tear out and replace any part of a building, or other structure, on the "residence premises", but only when necessary to repair the system or appliance. However, such tear out and replacement coverage only applies to other structures if the water or steam causes actual damage to a building on the "residence premises".

We do not cover loss to the system or appliance from which this water or steam escaped.

For purposes of this provision, a plumbing system or household appliance does not include a sump, sump pump or related equipment or a roof drain, gutter, down spout or similar fixtures or equipment.

Section I - Exclusion A.3. Water Damage, Paragraphs a. and c. that apply to surface water and water below the surface of the ground do not apply to loss by water covered under c.(5) and (6) above.

Under 2.b. and c. above, any ensuing loss to property described in Coverages A and B not precluded by any other provision in this policy is covered.

## B. Coverage C - Personal Property

We insure for direct physical loss to the property described in Coverage C caused by any of the following perils unless the loss is excluded under Section I - Exclusions.

### 1. Fire Or Lightning

#### 2. Windstorm Or Hail

This peril includes loss to watercraft of all types and their trailers, furnishings, equipment, and outboard engines or motors, only while inside a fully enclosed building.

This peril does not include loss to the property contained in a building caused by rain, snow, sleet, sand or dust unless the direct force of wind or hail damages the building causing an opening in a roof or wall and the rain, snow, sleet, sand or dust enters through this opening.

#### 3. Explosion

## 4. Riot Or Civil Commotion

#### 5. Aircraft

This peril includes self-propelled missiles and spacecraft.

#### 6. Vehicles

#### 7. Smoke

This peril means sudden and accidental damage from smoke, including the emission or puffback of smoke, soot, fumes or vapors from a boiler, furnace or related equipment.

This peril does not include loss caused by smoke from agricultural smudging or industrial operations.

## 8. Vandalism Or Malicious Mischief

#### 9. Theft

- This peril includes attempted theft and loss of property from a known place when it is likely that the property has been stolen.
- This peril does not include loss caused by theft:
  - (1) Committed by an "insured":
  - (2) In or to a dwelling under construction, or of materials and supplies for use in the construction until the dwelling is finished and occupied;
  - (3) From that part of a "residence premises" rented by an "insured" to someone other than another "insured"; or
  - (4) That occurs off the "residence premises"
    - (a) Trailers, semitrailers and campers;
    - (b) Watercraft of all types, and their furnishings, equipment and outboard engines or motors; or
    - (c) Property while at any other residence owned by, rented to, or occupied by an "insured", except while an "insured" is temporarily living there. Property of an "insured" who is a student is covered while at the residence the student occupies to attend school as long as the student has been there at any time during the 60 days immediately before the loss.

#### 10. Falling Objects

This peril does not include loss to property contained in a building unless the roof or an outside wall of the building is first damaged by a falling object. Damage to the falling object itself is not included.

## 11. Weight Of Ice, Snow Or Sleet

This peril means weight of ice, snow or sleet which causes damage to property contained in a building.

#### 2. Accidental Discharge Or Overflow Of Water Or Steam

- a. This peril means accidental discharge or overflow of water or steam from within a plumbing, heating, air conditioning or automatic fire protective sprinkler system or from within a household appliance.
- b. This peril does not include loss:
  - To the system or appliance from which the water or steam escaped;
  - Caused by or resulting from freezing except as provided in Peril Insured Against 14. Freezing;
  - (3) On the "residence premises" caused by accidental discharge or overflow which occurs off the "residence premises"; or
  - (4) Caused by mold, fungus or wet rot unless hidden within the walls or ceilings or beneath the floors or above the ceilings of a structure.
- c. In this peril, a plumbing system or household appliance does not include a sump, sump pump or related equipment or a roof drain, gutter, downspout or similar fixtures or equipment.
- d. Section I Exclusion A.3. Water Damage, Paragraphs a. and c. that apply to surface water and water below the surface of the ground do not apply to loss by water covered under this peril.

## Sudden And Accidental Tearing Apart, Cracking, Burning Or Bulging

This peril means sudden and accidental tearing apart, cracking, burning or bulging of a steam or hot water heating system, an air conditioning or automatic fire protective sprinkler system, or an appliance for heating water.

We do not cover loss caused by or resulting from freezing under this peril.

#### 14. Freezing

- a. This peril means freezing of a plumbing, heating, air conditioning or automatic fire pro tective sprinkler system or of a household appliance but only if you have used reasonable care to:
  - (1) Maintain heat in the building; or
  - (2) Shut off the water supply and drain all systems and appliances of water.

However, if the building is protected by an automatic fire protective sprinkler system, you must use reasonable care to continue the water supply and maintain heat in the building for coverage to apply.

 In this peril, a plumbing system or household appliance does not include a sump, sump pump or related equipment or a roof drain, gutter, downspout or similar fixtures or equipment.

## 15. Sudden And Accidental Damage From Artificially Generated Electrical Current

This peril does not include loss to tubes, transistors, electronic components or circuitry that are a part of appliances, fixtures, computers, home entertainment units or other types of electronic apparatus.

### 16. Volcanic Eruption

This peril does not include loss caused by earthquake, land shock waves or tremors.

#### **SECTION I - EXCLUSIONS**

A. We do not insure for loss caused directly or indirectly by any of the following. Such loss is excluded regardless of any other cause or event contributing concurrently or in any sequence to the loss. These exclusions apply whether or not the loss event results in widespread damage or affects a substantial area.

#### 1. Ordinance Or Law

Ordinance or Law means any ordinance or law:

- Requiring or regulating the construction, demolition, remodeling, renovation or repair of property, including removal of any resulting debris. This Exclusion A.1.a. does not apply to the amount of coverage that may be provided for in E.11. Ordinance Or Law under Section I - Property Coverages;
- The requirements of which result in a loss in value to property; or
- c. Requiring any "insured" or others to test for, monitor, clean up, remove, contain, treat, detoxify or neutralize, or in any way respond to, or assess the effects of, pollutants.

Pollutants means any solid, liquid, gaseous or thermal irritant or contaminant, including smoke, vapor, soot, fumes, acids, alkalis, chemicals and waste. Waste includes materials to be recycled, reconditioned or reclaimed.

This Exclusion A.1. applies whether or not the property has been physically damaged.

#### 2. Earth Movement

Earth Movement means:

 Earthquake, including land shock waves or tremors before, during or after a volcanic eruption;

- b. Landslide, mudslide or mudflow;
- c. Subsidence or sinkhole; or
- d. Any other earth movement including earth sinking, rising or shifting;

caused by or resulting from human or animal forces or any act of nature unless direct loss by fire or explosion ensues and then we will pay only for the ensuing loss.

This Exclusion A.2. does not apply to loss by theft.

#### 3. Water Damage

Water Damage means:

- a. Flood, surface water, waves, tidal water, overflow of a body of water, or spray from any of these, whether or not driven by wind;
- Water or water-borne material which backs up through sewers or drains or which overflows or is discharged from a sump, sump pump or related equipment; or
- Water or water-borne material below the surface of the ground, including water which exerts pressure on or seeps or leaks through a building, sidewalk, driveway, foundation, swimming pool or other structure;

caused by or resulting from human or animal forces or any act of nature.

Direct loss by fire, explosion or theft resulting from water damage is covered.

#### 4. Power Failure

Power Failure means the failure of power or other utility service if the failure takes place off the "residence premises". But if the failure results in a loss, from a Peril Insured Against on the "residence premises", we will pay for the loss caused by that peril.

## 5. Neglect

Neglect means neglect of an "insured" to use all reasonable means to save and preserve property at and after the time of a loss.

#### 6. War

War includes the following and any consequence of any of the following:

- Undeclared war, civil war, insurrection, rebel-lion or revolution;
- b. Warlike act by a military force or military personnel; or
- Destruction, seizure or use for a military purpose.

Discharge of a nuclear weapon will be deemed a warlike act even if accidental.

#### 7. Nuclear Hazard

This Exclusion A.7. pertains to Nuclear Hazard to the extent set forth in M. Nuclear Hazard Clause under Section I - Conditions.

#### 8. Intentional Loss

Intentional Loss means any loss arising out of any act an "insured" commits or conspires to commit with the intent to cause a loss.

In the event of such loss, no "insured" is entitled to coverage, even "insureds" who did not commit or conspire to commit the act causing the loss.

#### 9. Governmental Action

Governmental Action means the destruction, confiscation or seizure of property described in Coverage A, B or C by order of any governmental or public authority.

This exclusion does not apply to such acts ordered by any governmental or public authority that are taken at the time of a fire to prevent its spread, if the loss caused by fire would be covered under this policy.

- B. We do not insure for loss to property described in Coverages A and B caused by any of the following. However, any ensuing loss to property described in Coverages A and B not precluded by any other provision in this policy is covered.
  - Weather conditions. However, this exclusion only applies if weather conditions contribute in any way with a cause or event excluded in A. above to produce the loss.
  - Acts or decisions, including the failure to act or decide, of any person, group, organization or governmental body.
  - 3. Faulty, inadequate or defective:
    - Planning, zoning, development, surveying, siting;
    - Design, specifications, workmanship, repair, construction, renovation, remodeling, grading, compaction;
    - c. Materials used in repair, construction, renovation or remodeling; or
    - d. Maintenance:

of part or all of any property whether on or off the "residence premises".

## **SECTION 1 - CONDITIONS**

A. Insurable Interest And Limit Of Liability

Even if more than one person has an insurable interest in the property covered, we will not be liable in any one loss:

- To an "insured" for more than the amount of such "insured's" interest at the time of loss; or
- For more than the applicable limit of liability.

## B. Duties After Loss

In case of a loss to covered property, we have no duty to provide coverage under this policy if the failure to comply with the following duties is prejudicial to us. These duties must be performed either by you, an "insured" seeking coverage, or a representative of either:

- 1. Give prompt notice to us or our agent;
- 2. Notify the police in case of loss by theft;
- Notify the credit card or electronic fund transfer card or access device company in case of loss as provided for in E.6. Credit Card, Electronic Fund Transfer Card Or Access Device, Forgery And Counterfeit Money under Section I - Property Coverages;
- Protect the property from further damage. If repairs to the property are required, you must:
  - Make reasonable and necessary repairs to protect the property; and
  - b. Keep an accurate record of repair ex-penses;
- 5. Cooperate with us in the investigation of a claim;
- Prepare an inventory of damaged personal property showing the quantity, description, actual cash value and amount of loss. Attach all bills, receipts and related documents that justify the figures in the inventory;
- 7. As often as we reasonably require:
  - a. Show the damaged property;
  - Provide us with records and documents we request and permit us to make copies; and
  - Submit to examination under oath, while not in the presence of another "insured", and sign the same;
- Send to us, within 60 days after our request, your signed, sworn proof of loss which sets forth, to the best of your knowledge and belief:
  - a. The time and cause of loss:
  - The interests of all "insureds" and all others in the property involved and all liens on the property;
  - Other insurance which may cover the loss;

- d. Changes in title or occupancy of the property during the term of the policy;
- e. Specifications of damaged buildings and detailed repair estimates;
- f. The inventory of damaged personal property described in 6. above;
- Receipts for additional living expenses incurred and records that support the fair rental value loss; and
- h. Evidence or affidavit that supports a claim under E.6. Credit Card, Electronic Fund Transfer Card Or Access Device, Forgery And Counterfeit Money under Section I -Property Coverages, stating the amount and cause of loss.

## C. Loss Settlement

In this Condition C., the terms "cost to repair or replace" and "replacement cost" do not include the increased costs incurred to comply with the enforcement of any ordinance or law, except to the extent that coverage for these increased costs is provided in E.11. Ordinance Or Law under Section I - Property Coverages. Covered property losses are settled as follows:

- 1. Property of the following types:
  - Personal property;
  - Awnings, carpeting, household appliances, outdoor antennas and outdoor equipment, whether or not attached to buildings;
  - c. Structures that are not buildings; and
  - d. Grave markers, including mausoleums;

at actual cash value at the time of loss but not more than the amount required to repair or replace.

- 2. Buildings covered under Coverage A or B at replacement cost without deduction for depreciation, subject to the following:
  - a. If, at the time of loss, the amount of insurance in this policy on the damaged building is 80% or more of the full replacement cost of the building immediately before the loss, we will pay the cost to repair or replace, after application of any deductible and without deduction for depreciation, but not more than the least of the following amounts:
    - (1) The limit of liability under this policy that applies to the building;
    - (2) The replacement cost of that part of the building damaged with material of like kind and quality and for like use; or
    - (3) The necessary amount actually spent to repair or replace the damaged building.

If the building is rebuilt at a new premises, the cost described in (2) above is limited to the cost which would have been incurred if the building had been built at the original premises.

- b. If, at the time of loss, the amount of insurance in this policy on the damaged building is less than 80% of the full replacement cost of the building immediately before the loss, we will pay the greater of the following amounts, but not more than the limit of liability under this policy that applies to the building:
  - The actual cash value of that part of the building damaged; or
  - (2) That proportion of the cost to repair or replace, after application of any deductible and without deduction for depreciation, that part of the building damaged, which the total amount of insurance in this policy on the dam-aged building bears to 80% of the replacement cost of the building.
- c. To determine the amount of insurance required to equal 80% of the full replacement cost of the building immediately before the loss, do not include the value of:
  - Excavations, footings, foundations, piers, or any other structures or de-vices that support all or part of the building, which are below the under-surface of the lowest basement floor;
  - (2) Those supports described in (1) above which are below the surface of the ground inside the foundation walls, if there is no basement; and
  - (3) Underground flues, pipes, wiring and drains.
- d. We will pay no more than the actual cash value of the damage until actual repair or replacement is complete. Once actual re-pair or replacement is complete, we will settle the loss as noted in 2.a. and b. above.

However, if the cost to repair or replace the damage is both:

- Less than 5% of the amount of insurance in this policy on the building; and
- (2) Less than \$2,500:

we will settle the loss as noted in 2.a. and b. above whether or not actual repair or replacement is complete.

e. You may disregard the replacement cost loss settlement provisions and make claim under this policy for loss to buildings on an actual cash value basis. You may then make claim for any additional liability according to the provisions of this Condition C. Loss Settlement, provided you notify us of your intent to do so within 180 days after the date of loss.

## D. Loss To A Pair Or Set

In case of loss to a pair or set we may elect to:

- Repair or replace any part to restore the pair or set to its value before the loss; or
- Pay the difference between actual cash value of the property before and after the loss.

## E. Appraisal

If you and we fail to agree on the amount of loss, either may demand an appraisal of the loss. In this event, each party will choose a competent and impartial appraiser within 20 days after receiving a written request from the other. The two appraisers will choose an umpire. If they cannot agree upon an umpire within 15 days, you or we may request that the choice be made by a judge of a court of record in the state where the "residence premises" is located. The appraisers will separately set the amount of loss. If the appraisers submit a written report of an agreement to us, the amount agreed upon will be the amount of loss. If they fail to agree, they will submit their differences to the umpire. A decision agreed to by any two will set the amount of loss.

Each party will:

- 1. Pay its own appraiser; and
- Bear the other expenses of the appraisal and umpire equally.

## F. Other Insurance And Service Agreement

If a loss covered by this policy is also covered by:

- Other insurance, we will pay only the proportion of the loss that the limit of liability that applies under this policy bears to the total amount of insurance covering the loss; or
- A service agreement, this insurance is excess over any amounts payable under any such agreement. Service agreement means a service plan, property restoration plan, home warranty or other similar service warranty agreement, even if it is characterized as insurance.

## G. Suit Against Us

No action can be brought against us unless there has been full compliance with all of the terms under Section I of this policy and the action is started within two years after the date of loss.

## H. Our Option

If we give you written notice within 30 days after we receive your signed, sworn proof of loss, we may repair or replace any part of the damaged property with material or property of like kind and quality.

## I. Loss Payment

We will adjust all losses with you. We will pay you unless some other person is named in the policy or is legally entitled to receive payment. Loss will be payable 60 days after we receive your proof of loss and:

- 1. Reach an agreement with you;
- 2. There is an entry of a final judgment; or
- 3. There is a filing of an appraisal award with us.

## J. Abandonment Of Property

We need not accept any property abandoned by an "insured".

## K. Mortgage Clause

- If a mortgagee is named in this policy, any loss payable under Coverage A or B will be paid to the mortgagee and you, as interests appear. If more than one mortgagee is named, the order of payment will be the same as the order of precedence of the mortgages.
- If we deny your claim, that denial will not apply to a valid claim of the mortgagee, if the mort-gagee:
  - Notifies us of any change in ownership, occupancy or substantial change in risk of which the mortgagee is aware;
  - Pays any premium due under this policy on demand if you have neglected to pay the premium; and
  - c. Submits a signed, sworn statement of loss within 60 days after receiving notice from us of your failure to do so. Paragraphs E. Appraisal, G. Suit Against Us and I. Loss Payment under Section I - Conditions also apply to the mortgagee.
- If we decide to cancel or not to renew this policy, the mortgagee will be notified at least 10 days before the date cancellation or nonrenewal takes effect.
- 4. If we pay the mortgagee for any loss and deny payment to you:
  - We are subrogated to all the rights of the mortgagee granted under the mortgage on the property; or

- b. At our option, we may pay to the mortga-gee the whole principal on the mortgage plus any accrued interest. In this event, we will receive a full assignment and transfer of the mortgage and all securities held as collateral to the mortgage debt.
- Subrogation will not impair the right of the mortgagee to recover the full amount of the mortgagee's claim.

## L. No Benefit To Bailee

We will not recognize any assignment or grant any coverage that benefits a person or organization holding, storing or moving property for a fee regardless of any other provision of this policy.

## M. Nuclear Hazard Clause

- "Nuclear Hazard" means any nuclear reaction, radiation, or radioactive contamination, all whether controlled or uncontrolled or however caused, or any consequence of any of these.
- Loss caused by the nuclear hazard will not be considered loss caused by fire, explosion, or smoke, whether these perils are specifically named in or otherwise included within the Perils Insured Against.
- This policy does not apply under Section I to loss caused directly or indirectly by nuclear hazard, except that direct loss by fire resulting from the nuclear hazard is covered.

## N. Recovered Property

If you or we recover any property for which we have made payment under this policy, you or we will notify the other of the recovery. At your option, the property will be returned to or retained by you or it will become our property. If the recovered property is returned to or retained by you, the loss payment will be adjusted based on the amount you received for the recovered property.

## O. Volcanic Eruption Period

One or more volcanic eruptions that occur within a 72 hour period will be considered as one volcanic eruption.

## P. Policy Period

This policy applies only to loss which occurs during the policy period.

## Q. Concealment Or Fraud

We provide coverage to no "insureds" under this policy if, whether before or after a loss, an "insured" has:

 Intentionally concealed or misrepresented any material fact or circumstance;

- 2. Engaged in fraudulent conduct; or
- 3. Made false statements; relating to this insurance.

## R. Loss Payable Clause

If the Declarations show a loss payee for certain listed insured personal property, the definition of "insured" is changed to include that loss payee with respect to that property.

If we decide to cancel or not renew this policy, that loss payee will be notified in writing.

## **SECTION II - LIABILITY COVERAGES**

## A. Coverage E - Personal Liability

If a claim is made or a suit is brought against an "insured" for damages because of "bodily injury" or "property damage" caused by an "occurrence" to which this coverage applies, we will:

- Pay up to our limit of liability for the damages for which an "insured" is legally liable. Dam-ages include prejudgment interest awarded against an "insured"; and
- 2. Provide a defense at our expense by counsel of our choice, even if the suit is groundless, false or fraudulent. We may investigate and settle any claim or suit that we decide is appropriate. Our duty to settle or defend ends when our limit of liability for the "occurrence" has been exhausted by payment of a judgment or settlement.

## B. Coverage F - Medical Payments To Others

We will pay the necessary medical expenses that are incurred or medically ascertained within three years from the date of an accident causing "bodily injury". Medical expenses means reasonable charges for medical, surgical, x-ray, dental, ambulance, hospital, professional nursing, prosthetic devices and funeral services. This coverage does not apply to you or regular residents of your household except "residence employees". As to others, this coverage applies only:

- 1. To a person on the "insured location" with the permission of an "insured"; or
- To a person off the "insured location", if the "bodily injury":
  - Arises out of a condition on the "insured location" or the ways immediately adjoining;
  - b. Is caused by the activities of an "insured":
  - Is caused by a "residence employee" in the course of the "residence employee's" employment by an "insured"; or
  - d. Is caused by an animal owned by or in the care of an "insured".

## **SECTION II - EXCLUSIONS**

## A. "Motor Vehicle Liability"

- Coverages E and F do not apply to any "motor vehicle liability" if, at the time and place of an "occurrence", the involved "motor vehicle":
  - a. Is registered for use on public roads or property;
  - b. Is not registered for use on public roads or property, but such registration is required by a law, or regulation issued by a government agency, for it to be used at the place of the "occurrence"; or
  - c. Is being:
    - (1) Operated in, or practicing for, any prearranged or organized race, speed contest or other competition:
    - (2) Rented to others;
    - (3) Used to carry persons or cargo for a charge; or
    - (4) Used for any "business" purpose ex-cept for a motorized golf cart while on a golfing facility.
- If Exclusion A.1. does not apply, there is still no coverage for "motor vehicle liability" unless the "motor vehicle" is:
  - a. In dead storage on an "insured location";
  - Used solely to service an "insured's" residence;
  - Designed to assist the handicapped and, at the time of an "occurrence", it is:
    - Being used to assist a handicapped person; or
    - (2) Parked on an "insured location":
  - d. Designed for recreational use off public roads and:
    - (1) Not owned by an "insured"; or
    - (2) Owned by an "insured" provided the "occurrence" takes place on an "insured location" as defined in Definitions B. 6.a., b., d., e. or h.; or
  - e. A motorized golf cart that is owned by an "insured", designed to carry up to 4 per-sons, not built or modified after manufac-ture to exceed a speed of 25 miles per hour on level ground and, at the time of an "occurrence", is within the legal boundaries of:
    - A golfing facility and is parked or stored there, or being used by an "insured" to:
      - (a) Play the game of golf or for other recreational or leisure activity allowed by the facility;

- (b) Travel to or from an area where "motor vehicles" or golf carts are parked or stored; or
- (c) Cross public roads at designated points to access other parts of the golfing facility; or
- (2) A private residential community, including its public roads upon which a motorized golf cart can legally travel, which is subject to the authority of a property owners association and contains an "insured's" residence.

## B. "Watercraft Liability"

- Coverages E and F do not apply to any "watercraft liability" if, at the time of an "occurrence", the involved watercraft is being:
  - Operated in, or practicing for, any prearranged or organized race, speed contest or other competition. This exclusion does not apply to a sailing vessel or a predicted log cruise;
  - b. Rented to others;
  - Used to carry persons or cargo for a charge; or
  - d. Used for any "business" purpose.
- If Exclusion B.1. does not apply, there is still no coverage for "watercraft liability" unless, at the time of the "occurrence", the watercraft:
  - a. Is stored;
  - Is a sailing vessel, with or without auxiliary power, that is:
    - (1) Less than 26 feet in overall length; or
    - (2) 26 feet or more in overall length and not owned by or rented to an "insured"; or
  - c. Is not a sailing vessel and is powered by:
    - An inboard or inboard-outdrive engine or motor, including those that power a water jet pump, of:
      - (a) 50 horsepower or less and not owned by an "insured"; or
      - (b) More than 50 horsepower and not owned by or rented to an "insured"; or
    - (2) One or more outboard engines or motors with:
      - (a) 25 total horsepower or less;
      - (b) More than 25 horsepower if the outboard engine or motor is not owned by an "insured";
      - (c) More than 25 horsepower if the outboard engine or motor is owned by an "insured" who ac-quired it during the policy period; or

- (d) More than 25 horsepower if the outboard engine or motor is owned by an "insured" who ac-quired it before the policy period, but only if:
  - (i) You declare them at policy inception; or
  - (ii) Your intent to insure them is reported to us in writing within 45 days after you acquire them.

The coverages in (c) and (d) above apply for the policy period.

Horsepower means the maximum power rating assigned to the engine or motor by the manufacturer.

## C. "Aircraft Liability"

This policy does not cover "aircraft liability".

D. "Hovercraft Liability"

This policy does not cover "hovercraft liability".

E. Coverage E - Personal Liability And Coverage F - Medical Payments To Others

Coverages E and F do not apply to the following:

## 1. Expected Or Intended Injury

"Bodily injury" or "property damage" which is expected or intended by an "insured" even if the resulting "bodily injury" or "property damage":

- a. Is of a different kind, quality or degree than initially expected or intended; or
- Is sustained by a different person, entity, real or personal property, than initially ex-pected or intended.

However, this Exclusion E.1. does not apply to "bodily injury" resulting from the use of reasonable force by an "insured" to protect persons or property;

#### 2. "Business"

a. "Bodily injury" or "property damage" arising out of or in connection with a "business" conducted from an "insured location" or engaged in by an "insured", whether or not the "business" is owned or operated by an "insured" or employs an "insured".

This Exclusion E.2. applies but is not limited to an act or omission, regardless of its nature or circumstance, involving a service or duty rendered, promised, owed, or implied to be provided because of the nature of the "business".

- b. This Exclusion E.2. does not apply to:
  - (1) The rental or holding for rental of an "insured location";

- (a) On an occasional basis if used only as a residence:
- (b) In part for use only as a residence, unless a single family unit is intended for use by the occupying family to lodge more than two roomers or boarders; or
- (c) In part, as an office, school, studio or private garage; and
- (2) An "insured" under the age of 21 years involved in a part-time or occasional, self-employed "business" with no employees;

## 3. Professional Services

"Bodily injury" or "property damage" arising out of the rendering of or failure to render professional services:

## 4. "Insured's" Premises Not An "Insured Location"

"Bodily injury" or "property damage" arising out of a premises:

- a. Owned by an "insured";
- b. Rented to an "insured"; or
- c. Rented to others by an "insured";

that is not an "insured location";

#### 5. War

"Bodily injury" or "property damage" caused directly or indirectly by war, including the following and any consequence of any of the following:

- Undeclared war, civil war, insurrection, rebellion or revolution;
- b. Warlike act by a military force or military personnel; or
- Destruction, seizure or use for a military purpose.

Discharge of a nuclear weapon will be deemed a warlike act even if accidental;

## 6. Communicable Disease

"Bodily injury" or "property damage" which arises out of the transmission of a communicable disease by an "insured":

## 7. Sexual Molestation, Corporal Punishment Or Physical Or Mental Abuse

"Bodily injury" or "property damage" arising out of sexual molestation, corporal punishment or physical or mental abuse; or

## 8. Controlled Substance

"Bodily injury" or "property damage" arising out of the use, sale, manufacture, delivery, transfer or possession by any person of a Controlled Substance as defined by the Federal Food and Drug Law at 21 U.S.C.A. Sections 811 and 812. Controlled Substances include but are not limited to cocaine, LSD, marijuana and all narcotic drugs. However, this exclusion does not apply to the legitimate use of prescription drugs by a person following the orders of a licensed physician.

Exclusions A. "Motor Vehicle Liability", B. "Water-craft Liability", C. "Aircraft Liability", D. "Hovercraft Liability" and E.4. "Insured's" Premises Not An "Insured Location" do not apply to "bodily injury" to a "residence employee" arising out of and in the course of the "residence employee's" employment by an "insured".

## F. Coverage E - Personal Liability

Coverage E does not apply to:

- 1. Liability:
  - For any loss assessment charged against you as a member of an association, corporation or community of property owners, except as provided in D. Loss Assessment under Section II - Additional Coverages;
  - Under any contract or agreement entered into by an "insured". However, this exclu-sion does not apply to written contracts:
    - (1) That directly relate to the ownership, maintenance or use of an "insured location"; or
    - (2) Where the liability of others is as-sumed by you prior to an "occurrence";

unless excluded in a. above or elsewhere in this policy;

- "Property damage" to property owned by an "insured". This includes costs or expenses incurred by an "insured" or others to repair, replace, enhance, restore or maintain such property to prevent injury to a person or damage to property of others, whether on or away from an "insured location";
- "Property damage" to property rented to, oc-cupied or used by or in the care of an "insured".
  This exclusion does not apply to "property damage" caused by fire, smoke or explosion;
- "Bodily injury" to any person eligible to receive any benefits voluntarily provided or required to be provided by an "insured" under any:
  - a. Workers' compensation law;

- b. Non-occupational disability law; or
- c. Occupational disease law;
- 5. "Bodily injury" or "property damage" for which an "insured" under this policy:
  - a. Is also an insured under a nuclear energy liability policy issued by the:
    - Nuclear Energy Liability Insurance Association;
    - Mutual Atomic Energy Liability Underwriters;
    - Nuclear Insurance Association of Canada;

or any of their successors; or

- Would be an insured under such a policy but for the exhaustion of its limit of liability; or
- "Bodily injury" to you or an "insured" as defined under Definitions 5.a. or b.

This exclusion also applies to any claim made or suit brought against you or an "insured":

- a. To repay; or
- b. Share damages with;

another person who may be obligated to pay damages because of "bodily injury" to an "insured".

## G. Coverage F - Medical Payments To Others

Coverage F does not apply to "bodily injury":

- 1. To a "residence employee" if the "bodily injury":
  - a. Occurs off the "insured location"; and
  - b. Does not arise out of or in the course of the "residence employee's" employment by an "insured";
- To any person eligible to receive benefits vol-untarily provided or required to be provided under any:
  - a. Workers' compensation law;
  - Non-occupational disability law; or
  - c. Occupational disease law;
- From any:
  - a. Nuclear reaction:
  - b. Nuclear radiation; or
  - c. Radioactive contamination;

all whether controlled or uncontrolled or however caused; or

- d. Any consequence of any of these; or
- To any person, other than a "residence em-ployee" of an "insured", regularly residing on any part of the "insured location".

## **SECTION II - ADDITIONAL COVERAGES**

We cover the following in addition to the limits of liability:

#### A. Claim Expenses

We pay:

- Expenses we incur and costs taxed against an "insured" in any suit we defend;
- Premiums on bonds required in a suit we defend, but not for bond amounts more than the Coverage E limit of liability. We need not apply for or furnish any bond;
- Reasonable expenses incurred by an "insured" at our request, including actual loss of earnings (but not loss of other income) up to \$250 per day, for assisting us in the investigation or defense of a claim or suit; and
- 4. Interest on the entire judgment which accrues after entry of the judgment and before we pay or tender, or deposit in court that part of the judgment which does not exceed the limit of liability that applies.

### B. First Aid Expenses

We will pay expenses for first aid to others incurred by an "insured" for "bodily injury" covered under this policy. We will not pay for first aid to an "insured".

## C. Damage To Property Of Others

- We will pay, at replacement cost, up to \$1,000 per "occurrence" for "property damage" to property of others caused by an "insured".
- 2. We will not pay for "property damage":
  - To the extent of any amount recoverable under Section I;
  - b. Caused intentionally by an "insured" who is 13 years of age or older;
  - c. To property owned by an "insured";
  - d. To property owned by or rented to a ten-ant of an "insured" or a resident in your household; or
  - e. Arising out of:
    - (1) A "business" engaged in by an "insured";
    - (2) Any act or omission in connection with a premises owned, rented or controlled by an "insured", other than the "insured location"; or
    - (3) The ownership, maintenance, occupancy, operation, use, loading or unloading of aircraft, hovercraft, watercraft or "motor vehicles".

This exclusion e.(3) does not apply to a "motor vehicle" that:

- (a) Is designed for recreational use off public roads;
- (b) Is not owned by an "insured"; and
- (c) At the time of the "occurrence", is not required by law, or regulation issued by a government agency, to have been registered for it to be used on public roads or property.

#### D. Loss Assessment

- We will pay up to \$1,000 for your share of loss assessment charged against you, as owner or tenant of the "residence premises", during the policy period by a corporation or association of property owners, when the assessment is made as a result of:
  - a. "Bodily injury" or "property damage" not excluded from coverage under Section II - Exclusions; or
  - b. Liability for an act of a director, officer or trustee in the capacity as a director, officer or trustee, provided such person:
    - Is elected by the members of a corporation or association of property owners; and
    - (2) Serves without deriving any income from the exercise of duties which are solely on behalf of a corporation or association of property owners.
- Paragraph I. Policy Period under Section II Conditions does not apply to this Loss Assessment Coverage.
- Regardless of the number of assessments, the limit of \$1,000 is the most we will pay for loss arising out of:
  - One accident, including continuous or repeated exposure to substantially the same general harmful condition; or
  - A covered act of a director, officer or trustee.
     An act involving more than one director, officer or trustee is considered to be a single act.
- We do not cover assessments charged against you or a corporation or association of property owners by any governmental body.

#### **SECTION II - CONDITIONS**

#### A. Limit Of Liability

Our total liability under Coverage E for all damages resulting from any one "occurrence" will not be more than the Coverage E limit of liability shown in the Declarations. This limit is the same regardless of the number of "insureds", claims made or persons injured. All "bodily injury" and "property damage" resulting from any one accident or from continuous or repeated exposure to substantially the same general harmful conditions shall be considered to be the result of one "occurrence".

Our total liability under Coverage F for all medical expense payable for "bodily injury" to one person as the result of one accident will not be more than the Coverage F limit of liability shown in the Declarations.

#### B. Severability Of Insurance

This insurance applies separately to each "insured". This condition will not increase our limit of liability for any one "occurrence".

#### C. Duties After "Occurrence"

In case of an "occurrence", you or another "insured" will perform the following duties that apply. We have no duty to provide coverage under this policy if your failure to comply with the following duties is prejudicial to us. You will help us by seeing that these duties are performed:

- Give written notice to us or our agent as soon as is practical, which sets forth;
  - The identity of the policy and the "named insured" shown in the Declarations;
  - Reasonably available information on the time, place and circumstances of the "occurrence"; and
  - Names and addresses of any claimants and witnesses;
- Cooperate with us in the investigation, settlement or defense of any claim or suit;
- Promptly forward to us every notice, demand, summons or other process relating to the "occurrence":
- 4. At our request, help us:
  - To make settlement;
  - To enforce any right of contribution or indemnity against any person or organiza-tion who may be liable to an "insured";

- With the conduct of suits and attend hearings and trials; and
- To secure and give evidence and obtain the attendance of witnesses;
- With respect to C. Damage To Property Of Others under Section II - Additional Cover-ages, submit to us within 60 days after the loss, a sworn statement of loss and show the damaged property, if in an "insured's" control;
- No "insured" shall, except at such "insured's" own
  cost, voluntarily make payment, assume obligation or incur expense other than for first aid to
  others at the time of the "bodily injury".

## D. Duties Of An Injured Person - Coverage F - Medical Payments To Others

- The injured person or someone acting for the injured person will:
  - Give us written proof of claim, under oath if required, as soon as is practical; and
  - Authorize us to obtain copies of medical reports and records.
- The injured person will submit to a physical exam by a doctor of our choice when and as often as we reasonably require.

## E. Payment Of Claim - Coverage F - Medical Payments To Others

Payment under this coverage is not an admission of liability by an "insured" or us.

## F. Suit Against Us

- No action can be brought against us unless there has been full compliance with all of the terms under this Section II.
- No one will have the right to join us as a party to any action against an "insured".
- Also, no action with respect to Coverage E can be brought against us until the obligation of such "insured" has been determined by final judgment or agreement signed by us.

## G. Bankruptcy Of An "Insured"

Bankruptcy or insolvency of an "insured" will not relieve us of our obligations under this policy.

#### H. Other Insurance

This insurance is excess over other valid and collectible insurance except insurance written specifically to cover as excess over the limits of liability that apply in this policy.

### I. Policy Period

This policy applies only to "bodily injury" or "property damage" which occurs during the policy period.

## J. Concealment Or Fraud

We do not provide coverage to an "insured" who, whether before or after a loss, has:

- Intentionally concealed or misrepresented any material fact or circumstance:
- Engaged in fraudulent conduct; or
- Made false statements;

relating to this insurance.

## SECTIONS I AND II - CONDITIONS

## A. Liberalization Clause

If we make a change which broadens coverage under this edition of our policy without additional premium charge, that change will automatically apply to your insurance as of the date we implement the change in your state, provided that this implementation date falls within 60 days prior to or during the policy period stated in the Declarations.

This Liberalization Clause does not apply to changes implemented with a general program revision that includes both broadenings and restrictions in coverage, whether that general program revision is implemented through introduction of:

- 1. A subsequent edition of this policy; or
- An amendatory endorsement.

## B. Waiver Or Change Of Policy Provisions

A waiver or change of a provision of this policy must be in writing by us to be valid. Our request for an appraisal or examination will not waive any of our rights.

#### C. Cancellation

- You may cancel this policy at any time by returning it to us or by letting us know in writing of the date cancellation is to take effect.
- We may cancel this policy only for the reasons stated below by letting you know in writing of the date cancellation takes effect. This cancellation notice may be delivered to you, or mailed to you at your mailing address shown in the Declarations. Proof of mailing will be sufficient proof of notice.
  - a. When you have not paid the premium, we may cancel at any time by letting you know at least 10 days before the date cancellation takes effect.
  - b. When this policy has been in effect for less than 60 days and is not a renewal with us, we may cancel for any reason by letting you know at least 10 days before the date cancellation takes effect.

- c. When this policy has been in effect for 60 days or more, or at any time if it is a renewal with us, we may cancel:
  - If there has been a material misrepresentation of fact which if known to us would have caused us not to issue the policy; or
  - (2) If the risk has changed substantially since the policy was issued.

This can be done by letting you know at least 30 days before the date cancellation takes effect.

- d. When this policy is written for a period of more than one year, we may cancel for any reason at anniversary by letting you know at least 30 days before the date cancellation takes effect.
- When this policy is canceled, the premium for the period from the date of cancellation to the expiration date will be refunded pro rata.
- If the return premium is not refunded with the notice of cancellation or when this policy is returned to us, we will refund it within a reasonable time after the date cancellation takes effect.

#### D. Nonrenewal

We may elect not to renew this policy. We may do so by delivering to you, or mailing to you at your mailing address shown in the Declarations, written notice at least 30 days before the expiration date of this policy. Proof of mailing will be sufficient proof of notice.

#### E. Assignment

Assignment of this policy will not be valid unless we give our written consent.

### F. Subrogation

An "insured" may waive in writing before a loss all rights of recovery against any person. If not waived, we may require an assignment of rights of recovery for a loss to the extent that payment is made by us.

If an assignment is sought, an "insured" must sign and deliver all related papers and cooperate with us.

Subrogation does not apply to Coverage F or Paragraph C. Damage To Property Of Others under Section II - Additional Coverages.

#### G. Deatl

If any person named in the Declarations or the spouse, if a resident of the same household, dies, the following apply:

- We insure the legal representative of the deceased but only with respect to the premises and property of the deceased covered under the policy at the time of death; and
- 2. "Insured" includes:
  - a. An "insured" who is a member of your household at the time of your death, but only while a resident of the "residence premises";
     and
  - With respect to your property, the person having proper temporary custody of the property until appointment and qualification of a legal representative.

## PERSONAL PROPERTY REPLACEMENT COST LOSS SETTLEMENT

### A. Eligible Property

- 1. Covered losses to the following property are settled at replacement cost at the time of the loss:
  - Coverage C: and
  - b. If covered in this policy:
    - (1) Awnings, outdoor antennas and out-door equipment; and
    - (2) Carpeting and household appliances: whether or not attached to buildings.
- 2. This method of loss settlement will also apply to the following articles or classes of property if they are separately described and specifically insured in this policy and not subject to agreed value loss settlement:
  - Jewelry;
  - b. Furs and garments:

    - (2) Consisting principally of fur;
  - Cameras, projection machines, films and related articles of equipment:

- Any damage which occurred prior to policy inception regardless of whether such damages were apparent at the time of the inception of this policy or discovered at a later date;
- Any claims and/or damages caused by, arising out of, or resulting directly or indirectly, in whole or in part, from workmanship, repairs and/or lack of repairs relating to or arising from damages which occurred prior to policy inception; or
- c. Any claims and/or damages unless all structures covered by your previous policy have been fully and completely repaired. Prior to such completion of repairs, coverage will be limited to the actual cash value of the property at the time of a covered loss occurring during this policy period.

The following exclusion is added under SECTION I - EXCLUSIONS of the HOMEOWNERS 4 - CONTENTS BROAD FORM, and HOMEOWNERS 6 - UNIT - OWNERS FORM policies:

#### 10. Existing Damage

Existing Damage means the following:

- Any damages which occurred prior to policy inception regardless of whether such damages were apparent at the time of the inception of this policy or discovered at a later date;
- Any claims and/or damages caused by, arising out of, or resulting directly or indirectly, in whole or in part, from workmanship, repairs and/or lack of repairs relating to or arising from damage which occurred prior to policy inception; or
- c. Any claims and/or damages unless all structures covered by your previous policy have been fully and completely repaired. Prior to such completion of repairs, coverage will be limited to the actual cash value of the property at the time of a covered loss occurring during this policy period.

The following exclusion is added to Paragraph A. under GENERAL EXCLUSIONS of the DWELLING PROPERTY 3 - SPECIAL FORM policy:

#### 10. Existing Damage

Existing Damage means the following:

- Any damages which occurred prior to policy inception regardless of whether such damages were apparent at the time of the inception of this policy or discovered at a later date;
- Any claims and/or damages caused by, arising out of, or resulting directly or indirectly, in whole or in part, from workmanship, repairs and/or lack of repairs relating to or arising from damage which occurred prior to policy inception; or

c. Any claims and/or damages unless all structures covered by your previous policy have been fully and completely repaired. Prior to such completion of repairs, coverage will be limited to the actual cash value of the property at the time of a covered loss occurring during this policy period.

If any provision contained herein shall, for any reason, be held to be invalid, illegal or unenforceable in any respect, such provision shall be ineffective only to the extent of such invalidity, illegality or unenforceability, without invalidating the remainder of such provision.

All other terms an conditions of the policy remain the same.

## SPECIAL PROVISIONS - HAWAII

#### DEFINITIONS

The following definition is added:

"Domestic abuse", as used in this endorsement means:

- 1. Physical harm, bodily injury, assault or the infliction of fear of imminent physical harm, bodily injury or assault between family members;
- 2. Sexual assault of one family or household member by another:
- 3. Stalking of one family or household member by another family or household member; or
- Intentionally, knowingly or recklessly causing damage to property so as to intimidate or attempt to control the behavior of another family or household member.

## **SECTION I - EXCLUSIONS**

**8.** Intentional Loss is replaced by the following:

#### Intentional Loss

- a. Intentional Loss, means any loss arising out of any act an "insured" commits or conspires to commit with the intent to cause a loss.
  - In the event of such loss, no "insured" is entitled to coverage, even "insureds" who did not commit or conspire to commit the act causing the loss.
- **b.** However, this exclusion will not apply to deny an "insured's" claim for an otherwise covered property loss if such loss is caused by an act of "domestic abuse" by another "insured" under the policy, and the "insured" making claim:
  - (1) Files a police report and cooperates with any law enforcement investigation relating to the act of "domestic abuse"; and
  - (2) Did not cooperate in or contribute to the creation of the loss.
- c. If we pay a claim pursuant to Paragraph 8.b., our payment to the "insured" is limited to that "insured's" insurable interest in the property less any payments we first made to a mortgagee or other party with a legal secured interest in the property. In no event will we pay more than the limit of liability.

(This is Exclusion A.8. in Form HO 00 03.)

## SECTION I - CONDITIONS LOSS SETTLEMENT

In Forms HO 00 02, HO 00 03 and HO 00 05, Paragraph **2.d.** is replaced by the following:

- d. We will pay no more than the actual cash value of the damage unless:
  - (1) Actual repair or replacement is complete;
  - (2) The cost to repair or replace the damage is both:
    - (a) Less than 5% of the amount of insurance in this policy on the building; and
    - (b) Less than \$2500.
- I. Loss Payment is replaced by the following:

#### I. Loss Payment

We will adjust all losses with you. We will pay you unless some other person is named in the policy or is legally entitled to receive payment. Loss will be payable 30 days after we receive your proof of loss and:

- 1. Reach an agreement with you;
- 2. There is an entry of final judgment; or
- 3. There is a filing of an appraisal award with us.
- Q. Concealment Or Fraud is replaced by the following:

## O. Concealment Or Fraud

With respect to all "insureds" covered under this policy, concealment or misrepresentation, whether made before or after a loss, shall prevent recovery if it:

- 1. Was made with actual intent to deceive; or
- 2. Materially affects either the acceptance of the risk or the hazard assumed by us.

#### SECTION II - LIABILITY COVERAGES

## A. Coverage E - Personal Liability

Paragraph 1. is replaced by the following in all forms and Endorsement HO 24 73:

1. Pay up to our limit of liability for the damages for which the "insured" is legally liable; and

#### **SECTION II - CONDITIONS**

Paragraph A. Limit Of Liability is replaced by the following:

### A. Limit Of Liability

Our total liability under Coverage E for all damages resulting from any one "occurrence" will not be more than Coverage E the limit of liability shown in the Declarations. All "bodily injury" and "property damage" resulting from any one accident or from continuous or repeated exposure to substantially the same general harmful conditions shall be considered to be the result of one "occurrence".

## 2. Sub-limit Of Liability

Subject to Paragraph 1. above, our total liability under Coverage E for damages for which an "insured" is legally liable because of statutorily imposed vicarious parental liability not otherwise excluded is \$10,000. This sub-limit is within, but does not increase the Coverage E limit of liability.

- The limit of liability in 1. above and sub-limit in
   above apply regardless of the number of "insureds", claims made or persons injured.
- 4. Our total liability under Coverage F for all medical expense payable for "bodily injury" to one person as the result of one accident will not be more than the Coverage F limit of liability shown in the Declarations.
- 5. This Condition (A.) does not apply:
  - (a) To losses that are covered under the Home Business Endorsement, **HO 07 01:** or
  - (b) With respect to damages arising out of "fungi", wet or dry rot, or bacteria when Endorsements HO 04 26, HO 04 27 or HO 04 28 are attached.

J. Concealment Or Fraud is replaced by the following:

## J. Concealment Or Fraud

Concealment or misrepresentation by an "insured" covered under this policy, whether made before or after a loss, shall prevent recovery if it:

- (1) Was made with actual intent to deceive; or
- (2) Materially affects either the acceptance of the risk or the hazard assumed by us.

## SECTIONS I AND II - CONDITIONS

#### C. Cancellation

Paragraph 3. is replaced by the following:

3. When this policy is cancelled, the premium for the period from the date of cancellation to the expiration date will be refunded. When you request cancellation, the return premium will be based on our short rate procedure. When we cancel, the return premium will be pro rata.

## F. Subrogation

The following is added:

If we pay an "insured", who is a victim of "domestic abuse", for a loss caused by an act of "domestic abuse", the rights of that "insured" to recover damages from the perpetrator of the abuse are transferred to us to the extent of our payment. That "insured" may not waive such rights to recover against the perpetrator of the "domestic abuse".

All other provisions of this policy apply.
